INTRODUCTION. FIRST READING AND REFERENCE

By Assemblymen Ellison, Wheeler, Fiore, Dickman, Moore, Seaman and Titus:

Assembly Bill No. 136—AN ACT relating to wildlife; requiring the Department of Wildlife to issue a special hunting license to certain persons with disabilities; providing an exception from the requirement to complete a course in the responsibilities of hunters for certain persons with disabilities; authorizing a person hunting with archery equipment to carry a firearm; and providing other matters properly relating thereto.

Assemblyman Ellison moved that the bill be referred to the Committee on Natural Resources, Agriculture, and Mining.

Motion carried.

By Assemblymen Ellison, Wheeler, Hambrick, Fiore, Hansen, Armstrong, Dickman, Gardner, Hickey, Kirner, Munford, O'Neill, Oscarson, Seaman, Silberkraus, Stewart and Trowbridge; Senators Goicoechea and Settelmeyer:

Assembly Bill No. 137—AN ACT relating to contractors; revising provisions regarding the advertising of construction services and the soliciting of construction bids; increasing penalties for certain violations of provisions governing contractors; and providing other matters properly relating thereto.

Assembly Bill No. 138—AN ACT relating to juvenile justice; requiring the juvenile court to suspend a case if doubt arises as to whether a child is competent; requiring the juvenile court to appoint certain experts to evaluate a child and provide a written report on the competence of the child if the juvenile court suspends a case to determine whether the child is competent; requiring the juvenile court to hold an expedited hearing to determine whether a child is competent upon receipt of the written reports of all appointed experts; requiring the juvenile court to conduct a periodic review of a child determined to be incompetent; authorizing the juvenile court to terminate its jurisdiction in certain circumstances if a child has not attained competence and will be unable to attain competence in the foreseeable future; providing that a child determined to be incompetent may not be adjudicated a delinquent child or a child in need of supervision or placed under the supervision of the juvenile court during the period that the child remains incompetent; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 139—AN ACT relating to concealed firearms; authorizing a person who possesses a permit to carry a concealed firearm issued by another state to carry a concealed firearm in this State in accordance with the laws of this State; repealing certain other provisions concerning reciprocity of permits to carry concealed firearms; and providing other matters properly relating thereto.

Assembly Bill No. 142—AN ACT relating to wildlife; eliminating, under certain circumstances, the authority of the Board of Wildlife Commissioners and the Department of Wildlife to suspend or revoke a license, tag, permit, certificate or other document or privilege relating to wildlife; authorizing a court, under certain circumstances, to order the suspension or revocation of a license, tag, permit, certificate or other document or privilege relating to wildlife; eliminating the authority of the Commission to establish a system of assessing demerit points for wildlife convictions; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Natural Resources, Agriculture, and Mining.

By Assemblymen Carrillo, Elliot Anderson, Bustamante Adams, Diaz, Joiner, Neal, Ohrenschall, Stewart and Wheeler:

Assembly Bill No. 143—AN ACT relating to motor vehicles; authorizing an insurer who provides a contract of insurance for the operation of a motor vehicle to provide, upon the request of the insured and to the extent available, evidence of that insurance in an electronic format that can be displayed on a mobile electronic device; prohibiting a peace officer to whom such a device is presented for the purpose of showing evidence of insurance from viewing any other content on the device; providing that the person presenting such a device for the purpose of showing evidence of insurance assumes all liability for any damage to the device; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Carrillo moved that the bill be referred to the Committee on Transportation.

Assembly Bill No. 144—AN ACT relating to land use planning; revising provisions governing the membership of the Executive Council of the Land

Use Planning Advisory Council; requiring that any recommendations and proposed regulations relating to land use planning policies in areas of critical environmental concern be developed by the Land Use Planning Advisory Council; and providing other matters properly relating thereto.

Assemblywoman Titus moved that the bill be referred to the Committee on Natural Resources, Agriculture, and Mining.

By the Committee on Transportation:

Assembly Bill No. 145—AN ACT relating to motor vehicle registration; revising provisions governing the pro rata refund of registration fees and governmental services tax paid on a vehicle that is due when the registration is cancelled under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Wheeler moved that the bill be referred to the Committee on Transportation.

By the Committee on Transportation:

Assembly Bill No. 146—AN ACT relating to air pollution; revising provisions governing the frequency of required inspections of the emissions of certain motor vehicles; increasing fees charged by the Department of Motor Vehicles for certain forms; and providing other matters properly relating thereto.

Assemblyman Wheeler moved that the bill be referred to the Committee on Transportation.

Assembly Bill No. 147—AN ACT relating to taxation; revising provisions governing the total amount of transferable tax credits which may be approved by the Office of Economic Development pursuant to applications submitted to the Office by a producer that produces a film, television or other media production in this State; and providing other matters properly relating thereto.
