#### GENERAL FILE AND THIRD READING

Assembly Bill No. 76.

Bill read third time.

Remarks by Assemblywoman Diaz.

ASSEMBLYWOMAN DIAZ:

Assembly Bill 76 requires that the Department of Education shares with the Interagency Council on Veterans Affairs aggregate data collected concerning each pupil whose parent or guardian is a member of the Armed Forces of the United States, a reserve component thereof, or the National Guard. The bill also encourages the Board of Regents of the Nevada System of Higher Education to foster a culture that recognizes and supports veterans, and extends from two years to five years the time period a veteran who has been honorably discharged is eligible for resident or in-state fee charges.

Finally, A.B. 76 requires that the Board of Regents submit, on or before November 30 of each year, a report to the Legislature, or the Legislative Committee on Education when the Legislature is not in regular session, concerning the participation of students who are veterans in the Nevada System of Higher Education. This bill is effective on July 1, 2015.

I just want to clarify that the net effect of this bill is that veterans will be treated in the same manner as residents who do not pay tuition but who do pay fees.

Assembly Joint Resolution No. 10—Proposing to amend the Nevada Constitution to provide a citizens' commission to establish the salaries of certain elected officers.

WHEREAS, The Nevada Legislature established the Commission to Review the Compensation of Constitutional Officers, Legislators, Supreme Court Justices, Judges of the Court of Appeals, District Judges and Elected County Officers in 1993; and

WHEREAS, While the Commission is empowered by law to review compensation, hold public hearings and make recommendations for revisions to compensation for the various offices within its purview, it serves a purely advisory function and its recommendations have no effect unless enacted by the Legislature; and

WHEREAS, A constitutional amendment is required to fully empower such a commission to engage in a comprehensive review of the compensation given to various officers within this State and put into effect its findings; now, therefore, be it

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That a new section, designated Section 33A, be added to Article 4 of the Nevada Constitution to read as follows:

- Sec. 33A. 1. The Legislature shall provide by law for a Citizens' Commission on Salaries for Certain Elected Officers.
- 2. The Commission must consist of seven member who have diverse personal and professional interests and reside in various geographical areas of this State of which:
  - (a) Two members are appointed by the Speaker of the Assembly;
  - (b) Two members are appointed by the Majority Leader of the Senate;
  - (c) Two members are appointed by the Governor; and
  - (d) One member is appointed by the Chief Justice of the Supreme Court.
- 3. Each member of the Commission must be a resident of this State and must not be a state officer, public employee or lobbyist, or a parent, spouse, sibling, child or dependent relative of a state officer, public employee or lobbyist.
- 4. Except as otherwise provided in this subsection, the term of office of each member of the Commission is 4 years. The Speaker of the Assembly and the Majority Leader of the Senate shall each appoint one of the members first appointed for an initial term of 2 years. The Governor shall appoint one of the members first appointed for an initial term of 2 years. If a vacancy occurs, the appointing authority shall fill the vacancy for the unexpired term in the same manner as the original appointment, within 30 days after the vacancy occurs. A member of the Commission may not serve more than two terms.
- 5. An appointing authority may remove a member of the Commission only for cause of incapacity, incompetence, neglect of duty, malfeasance in office or failure to meet a qualification set forth in subsection 3.
- 6. The Commission shall elect a Chair from among its members. Except as otherwise provided in this section, the Commission shall adopt rules of procedure for the conduct of its hearings and any other procedural rules it deems necessary to carry out its duties. The affirmative vote of a majority of all the members appointed to the Commission is required to take action.
  - 7. Members of the Commission are entitled to:
- (a) The compensation provided by law for members of the Commission on Judicial Discipline who are not judicial officers; and
- (b) The per diem allowance and travel expenses provided by law for state officers and employees generally.
  - 8. The Commission shall:
- (a) Study the relationship of salaries to the duties of the members of the Legislature, the Governor, Lieutenant Governor, Secretary of State, State Treasurer, State Controller, Attorney General, justices of the Supreme Court, judges of the Court of Appeals and judges of the District Courts:
- (b) Compare the salaries of the elected officers set forth in paragraph (a) to the salaries of persons who are employed by a public or private employer and who have similar qualifications as those elected officers;
  - (c) Fix the salaries of the elected officers set forth in paragraph (a); and
  - (d) Carry out any duties provided by the Legislature.
- 9. The Commission may increase, but not diminish, the salary of an elected officer set forth in paragraph (a) of subsection 8 during his or her term of office. Except for the initial schedule of salaries for elected officers filed pursuant to subsection 10, the Commission may not increase or decrease the salary of any elected officer by more than 15 percent of the salary of that elected officer provided in the immediately preceding schedule of salaries for elected officers. The Commission may exercise any powers conferred by the Legislature.
- 10. The Commission shall file its initial schedule of salaries for elected officers with the Secretary of State not later than January 1, 2019, and shall file a schedule of salaries not later than January 1 of each odd-numbered year thereafter. Each schedule of salaries is effective for the period from July 1 immediately following the January 1 that the schedule is due through June 30 of the next odd-numbered year. The Legislature shall provide by law for setting apart from each year's revenues a sufficient amount of money to pay such salaries.

- 11. Before the Commission may file a schedule of salaries with the Secretary of State, the Commission shall hold at least four meetings to receive public testimony on the schedule. At the last public hearing before the schedule is filed with the Secretary of State, the Commission shall adopt the schedule as originally proposed or as amended. All meetings of the Commission are subject to the provisions of any open meeting laws made applicable generally to other public bodies.
- 12. The Legislative Counsel Bureau shall include in the Nevada Revised Statutes a copy of the most recent schedule of salaries established by the Commission and filed with the Secretary of State.

And be it further

RESOLVED, That Section 33 of Article 4 of the Nevada Constitution be amended to read as follows:

Sec. 33. The members of the Legislature shall receive for their services a compensation to be fixed by [law] the Citizens' Commission on Salaries for Certain Elected Officers pursuant to Section 33A of this Article and paid out of the public treasury, for [not to exceed 60 days] each calendar day of service during any regular session of the Legislature and [not to exceed 20 days] during any special session. [; but no increase of such compensation shall take effect during the term for which the members of either house shall have been elected; Provided, that an] An appropriation may be made for the payment of such actual expenses as members of the Legislature may incur for postage, express charges, newspapers and stationery not exceeding the sum of Sixty dollars for any general or special session to each member; and Furthermore Provided, that the Speaker of the Assembly, and Lieutenant Governor, as President of the Senate, shall each, during the time of their actual attendance as such presiding officers receive an additional allowance of two dollars per diem.

And be it further

RESOLVED, That Section 15 of Article 6 of the Nevada Constitution be amended to read as follows:

Sec. 15. The justices of the Supreme Court, the judges of the court of appeals and the district judges are each entitled to receive for their services a compensation to be fixed by <code>[law]</code> the Citizens' Commission on Salaries for Certain 1 Elected Officers pursuant to Section 33A of Article 4 and paid in the manner provided by law . [, which must not be increased or diminished during the term for which they have been elected, unless] If a vacancy occurs, <code>[in which case]</code> the successor of the former incumber entitled to receive <code>[only such salary as may be]</code> the salary provided for that office by <code>[law]</code> the Citizens' Commission on Salaries for Certain Elected Officers pursuant to Section 33A of Article 4 at the time of his or her election or appointment . [- A provision must be made by law for setting apart from each year's revenue a sufficient amount of money to pay such compensation.]

And be it further

RESOLVED, That Section 9 of Article 15 of the Nevada Constitution be repealed.

### TEXT OF REPEALED SECTION

Sec: 9. Increase or decrease of compensation of officers whose compensation fixed by constitution. The Legislature may, at any time, provide by law for increasing or diminishing the salaries or compensation of any of the Officers, whose salaries or compensation is fixed in this Constitution; Provided, no such change of Salary or compensation shall apply to any Officer during the term for which he may have been elected.

#### ASSEMBLYMAN ARMSTRONG:

Assembly Bill 70 provides for administration enforcement provisions related to the excise taxes on the sale of marijuana, edible marijuana products, and marijuana infused products by medical marijuana establishments that were originally approved by the Legislature in Senate Bill 374 of the 2013 Session. The administrative provisions contained within this bill are similar to the currently existing provisions used by the Department of Taxation for other taxes and fees currently administered by the Department. Assembly Bill 70 additionally removes provisions requiring the Department of Taxation to periodically review the excise tax rate and to provide recommendations to the Legislature relating to adjustments to the rate.

#### ASSEMBLYMAN OHRENSCHALL:

I need to make a disclosure to the body regarding Assembly Bill 70. Because we are considering Assembly Bill 70, which makes changes related to medical marijuana and its taxation, I would like to advise this body that my spouse lobbies on behalf of an association of marijuana dispensary owners. Although Assembly Bill 70 does not affect her clients any differently than any other dispensary owners or associations, I am making this disclosure and am abstaining from voting on Assembly Bill 70 out of an abundance of caution.

ASSEMBLYWOMAN CARLTON:

I rise in opposition to Assembly Bill 70. This body, a long time ago, decided that we would not tax medicine. Here we are making a huge sea change and actually taxing medicine in this state, and I am absolutely opposed to it. I feel it is the wrong path to go. If you want to tax this particular product, there are a number of bills out there that would allow us to do it in a legal, regulated way, and we could recognize it as we do other legal drugs and substances in this state. But to actually tax what is being classified as a medicine, I believe is absolutely wrong for the path of this state.
