INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Government Affairs:

Senate Bill No. 238—AN ACT relating to the City of Ely; disincorporating the City and forming the Town of Ely; and providing other matters properly relating thereto.

Senator Goicoechea moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Senator Roberson:

Senate Bill No. 239—AN ACT relating to real property; authorizing certain persons to file a notice to terminate a revolving line of credit secured by a deed of trust or mortgage; authorizing certain trustees to file a declaration of nonmonetary status under certain circumstances; revising provisions governing an action to declare void a trustee's sale; authorizing a beneficiary to substitute as trustee for the purpose of reconveying a deed of trust; providing that a failure to comply with the provisions of law governing a trustee's sale does not affect the validity of a sale in favor of a bona fide purchaser; and providing other matters properly relating thereto.

Senator Roberson moved that the bill be referred to the Committee on Judiciary.

By Senators Roberson, Hardy, Brower, Lipparelli, Farley, Gustavson, Hammond, Harris, Kieckhefer, Settelmeyer; Assemblymen Wheeler, Dickman and Paul Anderson:

Senate Bill No. 240—AN ACT relating to public safety; requiring a court to transmit within 5 business days certain records of adjudication concerning a person's mental health to the Central Repository for Nevada Records of Criminal History for certain purposes relating to the purchase or possession of a firearm; authorizing the inclusion, correction and removal of the information in such records in each appropriate database of the National Crime Information Center; requiring each agency of criminal justice to submit information relating to records of criminal history within 60 days after the date of the conviction; requiring the Central Repository, upon request, to conduct a background check without charge on a person who wishes to acquire a firearm; prohibiting certain persons from having possession, custody or control of a firearm; prohibiting certain persons from selling a firearm under certain circumstances; revising the functions of the Department of Health and Human Services; requiring a mental health professional to notify certain persons when a patient makes certain explicit threats of imminent serious physical harm or death; providing penalties; and providing other matters properly relating thereto.

Senator Roberson moved that the bill be referred to the Committee on Judiciary.

Senate Bill No. 241—AN ACT relating to collective bargaining; excluding school administrators from membership in a bargaining unit for the purposes of collective bargaining; and providing other matters properly relating thereto.

GENERAL FILE AND THIRD READING

Senate Bill No. 145.

Bill read third time.

Remarks by Senator Manendo.

Senate Bill No. 145 authorizes a member of the Armed Forces of the United States, a reserve component thereof or the National Guard, who is stationed at a military installation in Nevada to enroll in the Program for the Education of Motorcycle Riders.

Senate Bill No. 145 having received a constitutional majority, Mr. President declared it passed.

Senate Bill No. 156.

Bill read third time.

Remarks by Senator Parks.

Senate Bill No. 156 provides that a person who unlawfully proceeds through a temporary roadblock established because of flooding or water on the roadway is liable for the expenses of any emergency response that is required to: (1) remove the driver or any passenger from the vehicle; and/or (2) move or remove the vehicle from the roadway or any area near the roadway if the vehicle creates a hazard.

The bill also provides that a person who is convicted of reckless driving for driving a vehicle into any area temporarily covered by a rise in water may be liable for the expenses of any emergency response that is required to: (1) remove the driver or any passenger from the vehicle; and/or (2) move or remove the vehicle from the area.

The liability imposed by Senate Bill No. 156 must not exceed \$2,000 per incident.

Senate Bill No. 188.

Bill read third time.

Remarks by Senator Manendo.

Senate Bill No. 188 replaces the word "accident" or "collision" with "crash" in *Nevada Revised Statutes* where the term is used to refer to motor vehicle accidents. The bill also directs the Legislative Counsel to make conforming changes to the *Nevada Administrative Code*.

This bill is effective upon passage and approval for the purpose of adopting regulations or performing any preparatory administrative tasks that are necessary to carry out the provisions of the bill, and on January 1, 2016, for all other purposes.

There was discussion about trying to change attitudes and thoughts about this issue. As recently as this last Sunday, reporter Steve Sebelius, in his column, talked about "blood on the asphalt," and mentioned the word crash. I would like to give him kudos for that. Sadly, in Las Vegas, there was a TV news report about a group of friends gathering to remember two teens who were killed in a suspected DUI crash at Boulder Highway and Russell. Jennifer Kastner from the ABC affiliate Channel 13 in Las Vegas, used this term in her story as well. I think this is working. People in the media are using this terminology instead of the word accident, and I urge the passage of this bill.

REMARKS FROM THE FLOOR

Senator Woodhouse requested that her remarks be entered in the Journal.

March is Women's History Month and this past Sunday was International Women's Day, where people around the world celebrated the achievements of women while calling for greater equality. The 2015 theme for International Women's Day was "Make It Happen"—encouraging effective action for advancing and recognizing women globally.

With that theme in mind, I would like to go through some statistics for you. Many of you probably saw the report released over the weekend from WalletHub, where Nevada was ranked 8th worst state in the Country for women. For example, Nevada has the highest unemployment rate for women in the Country. We also ranked 50th in both female uninsured rates and women's preventative health care. We are 34th in high school dropout rates for women, and 28th in the percentage of those living in poverty.

Now, let us go beyond Nevada's boundaries. The United States is one of nine countries worldwide that does not provide for paid maternity leave. Women now earn the majority of college degrees in America, but they only make up 5 percent of Fortune 500 CEOs. American women only make 78 cents to every dollar a man makes for the same job. One-in-three women in the world will suffer physical or sexual violence. In state legislatures around the County, women only represent 24 percent of over 7,300 seats. Overall, America ranks 95th in the world for percentage of women in its National Legislature. After reading these statistics, one thing comes to mind: we can do better; we have to do better. And, to continue with the theme of Sunday's International Women's Day, let us "Make It Happen."

I want to remind all of my colleagues here, today, that as Legislators, we have an opportunity to take steps toward gender equality in Nevada every time we come into this building. This Session, we have a chance to pass an equal pay bill with some real teeth. We also have a chance to pass a clean bill that will protect survivors of domestic violence. There are countless other bills that can "Make It Happen."

When considering these pieces of legislation, I urge all of you to remember the statistics I just read. More importantly, I urge all of you to think of our daughters, our mothers, our sisters. Think of the women who contribute to Nevada every day, and fight for them. Thank you.
