## INTRODUCTION, FIRST READING AND REFERENCE

By Senators Atkinson, Spearman and Assemblyman Thompson:

Senate Bill No. 370—AN ACT relating to barbering; revising provisions relating to the examination for a license as an instructor of the practice of barbering; revising the number of instructors and barber's chairs required to be on the premises of a barber school; and providing other matters properly relating thereto.

Senator Atkinson moved that the bill be referred to the Committee on Commerce, Labor and Energy.

Senate Bill No. 371—AN ACT relating to apprentices; requiring the State Apprenticeship Council to approve or deny certain written requests submitted by a public body concerning the required use of an apprentice on a public work; authorizing the Council to suspend the right of a contractor on a public work to participate in a program of apprenticeship under certain circumstances; requiring a public body that awards a contract for a public work to ensure an apprentice performs a certain percentage of the total hours of labor on the public work; and providing other matters properly relating thereto.

Senate Bill No. 372—AN ACT relating to marijuana; requiring the Division of Public and Behavioral Health of the Department of Health and Human Services to select a provider of education and training by certified instructors for medical marijuana establishment agents; exempting the medical use of marijuana for animals from state prosecution in certain circumstances; requiring a cultivation facility to sell a certain amount of harvested marijuana within a certain time; prohibiting the governing body of a political subdivision from restricting the ability of a medical marijuana dispensary to obtain marijuana from any cultivation facility in this State; revising various provisions relating to registry identification cards; requiring the Division to issue medical marijuana establishment registration certificates based on population; revising various provisions relating to medical marijuana establishments and medical marijuana establishment agents; providing that certain records created by the Division relating to marijuana are not confidential; prohibiting retaliation or discrimination by an employer against certain employees for the use of certain marijuana products; revising provisions relating to driving a vehicle or operating watercraft under the influence of a prohibited substance to eliminate the use of the presence of a certain level of marijuana or marijuana metabolite; and providing other matters properly relating thereto.

Senator Ford moved that the bill be referred to the Committee on Health and Human Services.

Senate Bill No. 373—AN ACT relating to insurance; providing for the licensure of a producer of limited lines travel insurance; authorizing such producers to offer and disseminate travel insurance through certain travel retailers; and providing other matters properly relating thereto.

formula for calculating retirement allowances for persons who become members of certain public retirement systems on or after July 1, 2015; clarifying that the term "spouse" includes a domestic partner for purposes of eligibility for survivor benefits from a public retirement system; and providing other matters properly relating thereto.

Senator Roberson moved that the bill be referred to the Committee on Government Affairs.

Senate Bill No. 411—AN ACT relating to taxation; authorizing the board of trustees of a school district to adopt a resolution establishing the formation of a Public Schools Overcrowding and Repair Needs Committee to recommend the imposition of one or more statutory taxes to fund the capital projects of the school district; providing that if such a Committee is formed and submits its recommendations to the board of county commissioners within the time prescribed, the board of county commissioners is required to submit a question to the voters at the 2016 General Election asking whether the statutory tax or taxes should be imposed in the county; requiring the board of county commissioners to adopt an ordinance imposing any such statutory tax or taxes that are approved by the voters; providing for the prospective expiration of the authority of a board of trustees to establish such a Committee; and providing other matters properly relating thereto.
