**Senate Bill 459 (1st Reprint): Establishes an opioid overdose prevention policy for Nevada. (BDR 40-1199)**

**Kirsten Coloumbe:**

Section 7, subsection 1: "Notwithstanding any other provision of law, a health care professional otherwise authorized to prescribe an opioid antagonist may, directly or by standing order, prescribe and dispense an opioid antagonist to a person at risk of experiencing an opioid-related drug overdose or to a family member, friend or other person in a position to assist a person at risk of experiencing an opioid-related drug overdose."
