**Assembly Bill 487: Revises provisions governing firearms. (BDR 5-1279)** 

#### **Diane Thornton, Committee Policy Analyst:**

The bill is sponsored by Assemblymen Oscarson, Wheeler, Woodbury, Armstrong, Edwards, and cosponsors Silberkraus and Stewart. It was heard in this Committee on May 26, 2015. <u>Assembly Bill 487</u> authorizes a person who has a concealed firearm permit to carry a firearm capable of being concealed on the property of the Nevada System of Higher Education (NSHE). <u>Senate Bill 60 (2nd Reprint)</u> was heard in Committee on May 26, 2015, and transfers from the Secretary of State to the Attorney General the authority to issue fictitious addresses to certain persons and to provide funding necessary for the Attorney General to carry out the program of issuing fictitious addresses. The bill was sponsored by Senator Brower, and it was heard in this Committee on May 26, 2015.

Senate Bill 230 removes the statutory cap on the total amount of compensation the State Board of Examiners may award from the Fund for the Compensation of Victims of Crime to a victim, certain members of the victim's household, or dependents of the victim for expenses and losses.
