#### Chair Wheeler:

[Roll was taken. Protocol was explained.] We will do a quick work session on Senate Bill 144 (1st Reprint).

**Senate Bill 144 (1st Reprint)**: Revises provisions governing traffic laws. (BDR 43-72)

#### Michelle L. Van Geel, Committee Policy Analyst:

<u>Senate Bill 144 (1st Reprint)</u> was heard in this Committee on May 14, 2015. It is sponsored by Senator Manendo. <u>Senate Bill 144 (1st Reprint)</u> authorizes the Department of Transportation or the governing body of a local government to designate pedestrian safety zones and doubles the penalty for violating certain traffic laws within such zones. [Continued to read from work session document (Exhibit C).]

A sign must be placed before a pedestrian safety zone to warn that higher fines may apply, and additional signs must identify the beginning and end of such a zone. In the case where there is a flashing yellow turn arrow, <u>S.B. 144 (R1)</u> requires a vehicle to yield the right-of-way to other traffic or pedestrians lawfully in the intersection. The bill also prohibits a vehicle from passing another vehicle or making a U-turn in an active designated school zone.

In the work session document there is a conceptual amendment proposed by Senator Manendo following the discussion yesterday [page 3, (Exhibit C)]. The amendment would make two changes to the bill. First, it would make the additional penalty for committing certain traffic violations in a pedestrian safety zone discretionary instead of mandatory. Second, it would provide that if there are no signs erected which provide notice of the higher fines in the pedestrian safety zone and mark the beginning and end of the pedestrian safety zone, then a person is not subject to the additional penalty for committing certain traffic violations in a pedestrian safety zone.
