BDR S-1247—Makes a supplemental appropriation to the Department of Public Safety for projected costs for visiting dignitary protection assignments. (Later introduced as [Assembly Bill 465](#).)



- BDR 23-1154**—Revises provisions relating to the repayment of loans or other distributions of money made from the Renewable Energy Account to an officer or employee of the State. (Later introduced as [Assembly Bill 466](#).)
- BDR S-1235**—Makes a supplemental appropriation to the Department of Corrections for a shortfall resulting from a reduction in certain transfers for prison medical care. (Later introduced as [Assembly Bill 467](#).)
- BDR S-1236**—Makes supplemental appropriations to the Department of Corrections for shortfalls in projected personnel costs. (Later introduced as [Assembly Bill 468](#).)
- BDR 18-1180**—Creating the Office of Finance in the Office of the Governor. (Later introduced as [Assembly Bill 469](#).)
- BDR 23-1156**—Revises provisions governing the base for allocating costs of the Division of Human Resource Management of the Department of Administration to state agencies. (Later introduced as [Assembly Bill 470](#).)
- BDR 37-1158**—Revises provisions governing the Department of Veterans Services. (Later introduced as [Assembly Bill 471](#).)
- BDR 36-1163**—Revises provisions governing the use of money in the Patriot Relief Account. (Later introduced as [Assembly Bill 472](#).)
- BDR 18-1166**—Revises provisions governing the composition of the State Department of Conservation and Natural Resources. (Later introduced as [Assembly Bill 473](#).)
- BDR 10-1170**—Revises certain fees paid by homeowners' associations. (Later introduced as [Assembly Bill 474](#).)
- BDR 54-1171**—Revises provisions governing the financial administration of the Real Estate Division of the Department of Business and Industry. (Later as introduced as [Assembly Bill 475](#).)
- BDR 41-1172**—Revises provisions relating to unarmed combat. (Later introduced as [Assembly Bill 476](#).)
- BDR 58-1192**—Revises provisions concerning the duties of the Taxicab Administrator. (Later introduced as [Assembly Bill 477](#).)

- BDR 10-1173**—Revises certain fees collected by the Real Estate Division of the Department of Business and Industry and imposes certain new fees to be collected by the Division. (Later introduced as [Assembly Bill 478](#).)
- BDR 54-1174**—Provides for the licensing and regulation of mortgage loan servicers and revises provisions governing the administration of the Division of Mortgage Lending of the Department of Business and Industry. (Later introduced as [Assembly Bill 480](#).)
- BDR 52-1168**—Provides additional authority for the enforcement of the laws prohibiting deceptive trade practices. (Later introduced as [Assembly Bill 481](#).)
- BDR 34-1197**—Provides for the establishment of a Veterans Policy Leadership Institute within the Nevada System of Higher Education and provides for the preparation of certain reports relating to veterans. (Later introduced as [Assembly Bill 482](#).)
- BDR 34-1198**—Makes various changes relating to the compensation of certain public school employees. (Later introduced as [Assembly Bill 483](#).)
- BDR 43-1179**—Provides for the rolling reissuance of license plates by the Department of Motor Vehicles. (Later introduced as [Assembly Bill 484](#).)
- BDR 18-1155**—Revises provisions governing the duties and structure of the Office of Science, Innovation and Technology. (Later introduced as [Assembly Bill 485](#).)
- BDR 57-1169**—Revises provisions governing the budget accounts of the Division of Insurance of the Department of Business and Industry and certain fees collected by the Division. (Later introduced as [Assembly Bill 486](#).)
