## Chair Goicoechea:

I introduce <u>Bill Draft Request (BDR) S-709</u>, which calls for a ballot question to disincorporate the City of Ely, allowing the voters in the city to say yes or no.

<u>BILL DRAFT REQUEST S-709</u>: Revises provisions relating to cities. (Later introduced as Senate Bill 238.)

This BDR concerns the disincorporation of the City of Ely.

#### Chair Goicoechea:

There is new language in <u>Senate Bill (S.B.) 11</u>, as noted in the work session document (Exhibit C).

**SENATE BILL 11**: Grants power to local governments to perform certain acts or duties which are not prohibited or limited by statute. (BDR 20-284)

## Chair Goicoechea:

I have made it clear to cities that they can decide if they want to be part of this change. I have committed to members of the business sector that this new language does not allow for any new taxes or service fees. This is functional home rule, not fiscal home rule, even though it reduces Dillon's rule. I hope that opponents of the bill will come forward to indicate where their sentiments lie. The proposed amendment language is more palatable, but if you have issues, come to me to have them resolved. The effective date of this bill of June 30 may be changed to effective upon passage.

## Paul Enos (Nevada Trucking Association):

I have had only a few minutes to review the language. I would like to talk to the proponents of the bill, especially about section 13, subsection 2, of Proposed Amendment 9762. I would like clarification as to what "fairly implied" and "incident to powers" mean. I will speak to some in the business community and circle back to the Committee.

#### Chair Goicoechea:

Yes, come back to the members of the Committee and let me know where you stand. We have 48 hours.

## **Jeff Fontaine (Nevada Association of Counties):**

In regard to the language to which Mr. Enos referred, we want to provide assurances by even reasserting Dillon's Rule. Opponents are concerned that counties and cities will not be granted any new authority concerning business transactions and regulation.

## Heidi Chlarson (Counsel):

The amendment language that Mr. Enos referred to is at section 7, subsection 2. It was inserted because, under Dillon's Rule, the cities and the counties have powers "... expressly granted by statute or as necessarily or fairly implied in or incident to powers expressly granted in statute ... ." The intent of adding the new language is to make it clear that in addition to the powers expressly granted, cities and counties will still have power necessarily or fairly implied.
