Senator Kieckhefer:

Today we have Assembly Bill (A.B.) 29 on our agenda.

ASSEMBLY BILL 29: Revises provisions governing the care and treatment of persons with intellectual disabilities and related conditions. (BDR 39-324)

Jane Gruner (Administrator, Aging and Disability Services Division, Department of Health and Human Services):

This bill is a cleanup bill from when our divisions split from the Division of Mental Health and Developmental Services. The developmental service piece came over to the Aging and Disability Services Division. I have submitted written testimony (Exhibit C). Some of the language was left behind. This bill cleans up that portion. The corrective language addresses the sections governing individuals with intellectual disabilities. This bill will require certification from any providers versus just the nonprofits for jobs and day-training providers. The bill provides additional language to enable us to use the restrictive interventions that were already law; they did not move over with us.

Senator Kieckhefer:

This clarifies that all provisions relating to State facilities and State programs are also applicable to other structural organizations, private and nonprofit. Is that accurate?

Ms. Gruner:

Yes, that is accurate. Some of the language is changed. Now, it adds partnerships, firms, corporations and associations to the nonprofit organizations and local and State government agencies that may be certificated to provide jobs and day-training services.

Senator Kieckhefer:

Then there are no substantive policy changes in this legislation? Does it assure statutes conform to existing law and policy?

Ms. Gruner:

Yes, that would be accurate.

Senator Kieckhefer:

We will close the hearing on A.B. 29.

I have two bill draft requests (BDRs) for introduction, <u>BDR 40-981</u> and <u>BDR 38-982</u>.

<u>BILL DRAFT REQUEST 40-981</u>: Makes various changes relating to public health. (Later introduced as Senate Bill 247).
