I will open the meeting with Assembly Bill (A.B.) 40.

ASSEMBLY BILL 40 (1st Reprint): Revises provisions relating to the State Gaming Control Board. (BDR 41-352)

Terry Johnson (State Gaming Control Board):

Assembly Bill 40 seeks to carve out a very narrow exemption from the Open Meeting Law for the State Gaming Control Board for purposes of handling its investigations and complaints. The Board is an investigative body as part of the State's dual level gaming regulatory system. The Board investigates and

prosecutes matters and then refers those matters on to the Nevada Gaming Commission for adjudication.

The Board meets to discuss the content of a complaint, what information should be subject to the complaint and the conduct of the investigation rights of the complaint. Certain actions and proceedings of the Board should not have to be subject to provisions of the Open Meeting Law.

The Board seeks this legislation to give it a clear authority to meet to discuss such items without operating afoul of the State's Open Meeting Law. That is the essence of this proposed bill.

Assembly Bill 40 includes a minor housekeeping item of changing the name from the State Gaming Control Board to the Nevada Gaming Control Board. The rationale for that is at the time the Nevada Gaming Control Act was created, Nevada was the only state in the union that had a State Gaming Control Board. Now, almost all states have a similar regulatory body; so for clarification, that housekeeping item is being sought.
