**ASSEMBLY BILL 141**: Revises provisions relating to the foreclosure of liens by a homeowners' association. (BDR 10-751)

**ASSEMBLY BILL 362 (2nd Reprint)**: Revises provisions relating to domestic relations. (BDR 11-745)

**ASSEMBLY BILL 371 (1st Reprint)**: Establishes provisions governing the destruction of certain physical evidence. (BDR 4-734)
