# MINUTES OF THE SENATE COMMITTEE ON JUDICIARY

#### **Chair Brower:**

I will open the work session with Senate Bill (S.B.) 292.

**SENATE BILL 292**: Revises provisions relating to certain civil actions involving negligence. (BDR 3-954)

# Patrick Guinan (Policy Analyst):

I will read from the work session document on S.B. 292 (Exhibit C). The Committee submitted Proposed Amendment 7335 with the approval of Chair Brower.

#### Chair Brower:

Senator Roberson, can you walk the Committee through Proposed Amendment 7335?

#### Senator Roberson:

We deleted the proposed changes in section 4.

#### **Chair Brower:**

We are deleting the proposed changes in section 4 and leaving statute intact?

### **Senator Roberson:**

Yes. We added language to section 1 regarding the liability of a board of trustees of a school district when there is a school-based health center located on the premises of the school, which is reasonable.

In section 2, we clarified the definition for a provider of health care to include a professional corporation or physicians' group practice.

The biggest change is in section 4. We could not agree to this contentious provision. To move the bill forward, we removed section 4. The bill is a step in the right direction.

#### Senator Ford:

People can agree on this version of the bill.

SENATOR HARRIS MOVED TO AMEND AND DO PASS AS AMENDED S.B. 292 WITH PROPOSED AMENDMENT 7335.

SENATOR HAMMOND SECONDED THE MOTION.

### **Senator Segerblom:**

In Nevada, malpractice cases are almost impossible to prove. In the early 2000s, we had an issue with medical malpractice and laws were changed. It did not reduce the rates doctors must pay for malpractice insurance. Senate Bill 292 fixes a problem that does not exist. When a person commits malpractice and mistakenly cuts off another's arm, the injured person should receive compensation. Our system is as good as it is going to get. This bill makes malpractice worse and I cannot support it. I must oppose anything that makes it harder for a plaintiff or injured person to recover.

### Senator Kihuen:

I will vote against <u>S.B. 292</u>, but I reserve the right to change my vote on the Senate Floor.

### **Chair Brower:**

I believe the compromise language makes sense and moves us in the right direction. I do not believe it undermines a potential plaintiff's right to bring an action or recover damages.
