MINUTES OF THE SENATE COMMITTEE ON JUDICIARY

Seventy-Eighth Session February 20, 2015

The Senate Committee on Judiciary was called to order by Chair Greg Brower at 1:08 p.m. on Friday, February 20, 2015, in Room 2134 of the Legislative Building, Carson City, Nevada. The meeting was videoconferenced to Room 4412E of the Grant Sawyer State Office Building, 555 East Washington Avenue, Las Vegas, Nevada. Exhibit A is the Agenda. Exhibit B is the Attendance Roster. Chair Brower:

I will open the work session on Senate Bill (S.B.) 134.

SENATE BILL 134: Makes various changes relating to the provision of a bond in certain civil actions. (BDR 2-948)

Pat Guinan (Policy Analyst):

I will read the summary of the bill from the work session document (Exhibit C).

Chair Brower:

I understand Senator Ford has a proposed amendment for S.B. 134.

Senator Ford:

I will present my amendment to section 2, subsections 2, 3 and 4 of <u>S.B. 134</u> (<u>Exhibit D</u>). I spoke to the bill sponsor and the amendments are not acceptable; however, I request the Committee hear the amendments.

I propose to amend section 2, subsection 2 to state if there is an insurance policy, the bond can be set at the limit of the insurance policy.

The proposed amendment to section 2, subsection 3 states if the plaintiff proves by a preponderance of evidence the financial condition of the appellant, who posted a bond pursuant to subsection 1 or subsection 2, has materially changed and it is unlikely the appellant can pay the amount of the judgment, or the appellant is dissipating, selling or diverting assets to evade payment of the judgment, the trial judge shall require the appellant to post a bond in an amount not to exceed the full amount of the judgment or the amount set forth in subsection 1. The court can use its discretion to include awards for punitive or exemplary damages.

The proposed amendment to section 2, subsection 4 relates to good cause shown in allowing a court to require a bond in excess of or below the provisions of subsections 1, 2 and 3. When determining if the bond should be in excess of the provisions of those subsections, the court may not consider any award of punitive or exemplary damages. In determining the adequacy of the bond, the court may consider the following: the amount of economic damages determined by a trier of fact; the amount of noneconomic damages determined by a trier of fact; whether the insurer for any defendant refused to accept a settlement offer made within the policy limit of the defendant; and the strength of the defendant's appeal including whether the appeal concerns legal issues that require a de novo review or a matter of first impression before the court.

SENATOR FORD MOVED TO AMEND AND DO PASS AS AMENDED S.B. 134.

SENATOR KIHUEN SECONDED THE MOTION.

Chair Brower:

I reviewed the proposed amendment and the Committee benefits from your experience in this area. I am not in favor of the amendment because it undermines the purpose of the bill. The bill accomplishes the goal as introduced and does not need an amendment.

THE MOTION FAILED. (SENATORS BROWER, HAMMOND, HARRIS AND ROBERSON VOTED NO.)

SENATE BILL 9: Requires the Nevada Gaming Commission to adopt regulations relating to the development of technology in gaming. (BDR 41-61)

Mr. Guinan:

I will read the summary of the bill from the work session document (<u>Exhibit E</u>). There is a proposed amendment from the Association of Gaming Equipment Manufacturers.

Chair Brower:

This bill makes sense, especially with the proposed amendment.

SENATOR FORD MOVED TO AMEND AND DO PASS AS AMENDED S.B. 9 WITH THE PROPOSED AMENDMENT BY THE ASSOCIATION OF GAMING EQUIPMENT MANUFACTURERS.

SENATOR HARRIS SECONDED THE MOTION.

SENATE BILL 16: Revises provisions governing presentence and general investigations and reports made by the Division of Parole and Probation of the Department of Public Safety. (BDR 14-469)

Mr. Guinan:

I will read the summary of the bill from the work session document (<u>Exhibit F</u>). During the first Committee hearing, we identified the need to rerefer the bill to the Senate Committee on Finance.

Chair Brower:

We discussed whether the State or the county is responsible for the payment of the reports. The bill should be rereferred to the Senate Committee on Finance without recommendation.

SENATOR ROBERSON MOVED WITHOUT RECOMMENDATION TO REREFER S.B. 16 TO THE SENATE COMMITTEE ON FINANCE.

SENATOR HARRIS SECONDED THE MOTION.

SENATE BILL 17: Authorizes a deputy director of the Department of Corrections to accept employment as an instructor at an institution of higher education. (BDR 16-339)

Mr. Guinan:

I will read the summary of the bill from the work session document (<u>Exhibit G</u>). The Department of Corrections requests that the effective date would be upon passage instead of July 1.

Chair Brower:

Senator Harris, can you explain the purpose of Proposed Amendment 9651?

Senator Harris:

My proposed amendment refers to section 1, line 19 of the bill. The bill allows deputy directors of the Department of Corrections to teach on a part-time or adjunct basis for higher education institutions in Nevada. The bill amendment makes the intent clear.

SENATOR HARRIS MOVED TO AMEND AND DO PASS AS AMENDED S.B. 17 WITH PROPOSED AMENDMENT 9651 AND THE REQUEST FROM THE DEPARTMENT OF CORRECTIONS TO CHANGE THE EFFECTIVE DATE TO UPON PASSAGE AND APPROVAL.

SENATOR FORD SECONDED THE MOTION.

THE MOTION CARRIED UNANIMOUSLY.

SENATE BILL 36: Revises provisions governing state business licenses. (BDR 7-368)

Mr. Guinan:

I will read the summary of the bill from the work session document (Exhibit H).

The proposed amendment was previously discussed by the Committee.

SENATOR HARRIS MOVED TO AMEND AND DO PASS AS AMENDED S.B. 36 WITH THE PROPOSED AMENDMENT BY LEO DROZDOFF, DIRECTOR, STATE DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES.

SENATOR KIHUEN SECONDED THE MOTION.

THE MOTION CARRIED UNANIMOUSLY.

I will support the bill, but I still have concerns. I want to ensure people will act in good faith as they utilize this technology. Abuse and misuse of GPS devices is possible, but I feel this route is appropriate.
