#### **Chair Farley:**

I will open this work session on bills we heard earlier today as bill draft requests. The first is Assembly Bill (A.B.) 495.

ASSEMBLY BILL 495: Makes various changes relating to bill draft requests. (BDR 17-1283)

#### Michael Stewart (Policy Analyst):

This bill pertains to bill draft requests (BDRs). Proposed Amendment 7894 incorporates Senator Settelmeyer's changes to section 2 (Exhibit C).

Proposed Amendment 7894 requires an incumbent Assemblyperson to prefile four BDRs or inform the Legislative Counsel which of the four BDRs he or she wishes to withdraw. If an incumbent does not request his or her maximum number of BDRs, the number of prefiled BDRs must be reduced by that number of unused requests. This language also applies to incumbent Senators who must prefile eight BDRs. Newly elected Assemblypersons must prefile at least two BDRs and newly elected Senators must prefile at least four BDRs.

SENATOR SETTELMEYER MOVED TO AMEND AND DO PASS AS AMENDED A.B. 495 WITH PROPOSED AMENDMENT 7894.

SENATOR SEGERBLOM SECONDED THE MOTION.
