ASSEMBLY BILL 326 (2nd Reprint): Revises provisions governing motor vehicle registration. (BDR 43-1052)

The bill revises certain requirements for the issuance of a special license plate inscribed with the words "Old Timer," "Classic Rod" or "Classic Vehicle" providing that only vehicles made before 1996 are eligible for such plates.

The bill also prohibits the Department of Motor Vehicles from issuing these license plates, as well as the "Street Rod" license plate, for a period of 2 years, beginning July 1, 2015.
