<u>S.B. 146</u> (R2)	Revises provisions governing the filing of an integrated resources plan with the Public Utilities Commission of Nevada. (BDR 58-15)
<u>S.B. 150</u> (R1)	Revises provisions related to energy efficiency programs. (BDR 58-568)
<u>S.B. 481</u> (R2)	Creates the Nevada Commission for Persons Who Are Deaf, Hard of Hearing or Speech Impaired. (BDR 38-604)
S.B. 496	Revises provisions governing the issuance of revenue bonds and other securities by the Nevada System of Higher Education. (BDR S-1083)
<u>S.B. 518</u> (R1)	Revises provisions relating to certain accounts used for the education of pupils enrolled in public schools. (BDR 34-1094)
<u>S.B. 524</u> (R1)	Makes supplemental appropriations to the Division of Forestry of the State Department of Conservation and Natural Resources for a projected shortfall for certain activities. (BDR S-1173)
