THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Delete existing sections 1 through 7 of this bill and replace with the following
2 new sections 1 and 2:

4 Section 1. 1. The Legislative Committee on Senior Citizens, Veterans
5 and Adults with Special Needs created by NRS 218E.750 shall conduct a study
6 during the 2017-2018 interim concerning standards of training for persons
7 who are not providers of health care and who provide care to a person through
8 employment or a contractual arrangement with a facility for intermediate
9 care, facility for skilled nursing, facility for the care of adults during the day,
10 residential facility for groups, home for individual residential care, an agency
11 to provide nursing in the home or an agency to provide personal care services
12 in the home.

13 2. In conducting the study, the Committee shall consider:

14 (a) The specific types of training that a person who is not a provider of
15 health care must receive before providing care to a person in a facility or home
16 or through an agency described in subsection 1; and

17 (b) The creation of a competency evaluation that a person who is not a
18 provider of health care must successfully complete concerning the types of
19 care the person will provide at a facility or home or through an agency
20 described in subsection 1.

21 2. The Committee shall include in its report required by subsection 3 of
22 NRS 218E.760 on or before January 15, 2019, the results of the study
23 conducted pursuant to this section and any recommendations for legislation.

24 3. As used in this section:

25 (a) "Agency to provide nursing in the home" has the meaning ascribed to
26 it in NRS 449.0015.

27 (b) "Agency to provide personal care services in the home" has the
28 meaning ascribed to it in NRS 449.0021.

29 (c) "Facility for intermediate care" has the meaning ascribed to it in NRS
30 449.0038.

31 (d) "Facility for skilled nursing" has the meaning ascribed to it in NRS
32 449.0039.

33 (e) "Facility for the care of adults during the day" has the meaning
34 ascribed to it in NRS 449.004.

35 (f) "Home for individual residential care" has the meaning ascribed to it
36 in NRS 449.0105.

37 (g) "Residential facility for groups" has the meaning ascribed to it in NRS
38 449.017.
