AN ACT relating to driver authorization cards; revising provisions governing the administration of driver authorization cards; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law requires the Department of Motor Vehicles to adopt regulations prescribing the period for which a driver's license is valid. (NRS 483.380) Those regulations specify that a driver's license expires on the eighth anniversary or fourth anniversary of the birthday of the licensee, depending upon certain circumstances. (NAC 483.043) Under existing law a driver authorization card expires on the anniversary of its issuance or renewal. (NRS 483.291) **Section 1** of this bill removes the annual expiration requirement for a driver authorization card, and ~~Section 2 of this bill~~ requires instead that ~~the regulations which prescribe the date of expiration of a driver's license also prescribe the date of expiration of a driver authorization card and that they must be valid for the same period, unless otherwise required by federal law~~ **such a card expires on the fourth anniversary of the holder's birthday, measured from the birthday nearest the date of issuance or renewal.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 483.291 is hereby amended to read as follows:
483.291 1. An application for an instruction permit or for a driver authorization card must:
(a) Be made upon a form furnished by the Department.
(b) Be verified by the applicant before a person authorized to administer oaths. Officers and employees of the Department may administer those oaths without charge.
(c) Be accompanied by the required fee.
(d) State the name, date of birth, sex and residence address of the applicant and briefly describe the applicant.

1 (e) State whether the applicant has theretofore been licensed as a driver, and, if
2 so, when and by what state or country, and whether any such license has ever been
3 suspended or revoked, or whether an application has ever been refused, and, if so,
4 the date of and reason for the suspension, revocation or refusal.

5 (f) Include such other information as the Department may require to determine
6 the competency and eligibility of the applicant.

7 2. Every applicant must furnish proof of his or her name and age by
8 displaying an original or certified copy of:

9 (a) Any one of the following documents:

10 (1) A birth certificate issued by a state, a political subdivision of a state, the
11 District of Columbia or any territory of the United States;

12 (2) A driver's license issued by another state, the District of Columbia or
13 any territory of the United States which is issued pursuant to the standards
14 established by 6 C.F.R. Part 37, Subparts A to E, inclusive, and which contains a
15 security mark approved by the United States Department of Homeland Security in
16 accordance with 6 C.F.R. § 37.17;

17 (3) A passport issued by the United States Government;

18 (4) A military identification card or military dependent identification card
19 issued by any branch of the Armed Forces of the United States;

20 (5) For persons who served in any branch of the Armed Forces of the
21 United States, a report of separation;

22 (6) A Certificate of Degree of Indian *or Alaska Native* Blood issued by the
23 United States Government;

24 (7) A Certificate of Citizenship, Certificate of Naturalization, Permanent
25 Resident Card or Temporary Resident Card issued by the United States Citizenship
26 and Immigration Services of the Department of Homeland Security;

27 (8) A Consular Report of Birth Abroad issued by the Department of State;
28 or

29 (9) Such other documentation as specified by the Department by
30 regulation; or

31 (b) Any two of the following documents:

32 (1) A driver's license issued by another state, the District of Columbia or
33 any territory of the United States other than such a driver's license described in
34 subparagraph (2) of paragraph (a);

35 (2) A passport issued by a foreign government;

36 (3) A birth certificate issued by a foreign government;

37 (4) A consular identification card issued by the Government of Mexico or a
38 document issued by another government that the Department determines is
39 substantially similar; or

40 (5) Any other proof acceptable to the Department.

41 ➤ No document which is written in a language other than English may be accepted
42 by the Department pursuant to this subsection unless it is accompanied by a verified
43 translation of the document in the English language.

44 3. Every applicant must prove his or her residence in this State by displaying
45 an original or certified copy of any two of the following documents:

46 (a) A receipt from the rent or lease of a residence located in this State;

47 (b) A record from a public utility for a service address located in this State
48 which is dated within the previous 60 days;

49 (c) A bank or credit card statement indicating a residential address located in
50 this State which is dated within the previous 60 days;

51 (d) A stub from an employment check indicating a residential address located
52 in this State;

1 (e) A document issued by an insurance company or its agent, including,
2 without limitation, an insurance card, binder or bill, indicating a residential address
3 located in this State;

4 (f) A record, receipt or bill from a medical provider indicating a residential
5 address located in this State; or

6 (g) Any other document as prescribed by the Department by regulation.

7 4. Except as otherwise provided in subsection 5, a driver authorization card or
8 instruction permit obtained in accordance with this section must:

9 (a) Contain the same information as prescribed for a driver's license pursuant
10 to NRS 483.340 and any regulations adopted pursuant thereto;

11 (b) Be of the same design as a driver's license and contain only the minimum
12 number of changes from that design that are necessary to comply with subsection 5;
13 and

14 (c) Be numbered from the same sequence of numbers as a driver's license.

15 5. A driver authorization card or instruction permit obtained in accordance
16 with this section must comply with the requirements of section 202(d)(11) of the
17 Real ID Act of 2005, Public Law 109-13, Division B, Title II, 119 Stat. 302, 312-
18 15, 49 U.S.C. § 30301 note.

19 6. Notwithstanding the provisions of NRS 483.380, every ~~(Every)~~ driver
20 authorization card ~~expires on the anniversary of its issuance or renewal. Every~~
21 ~~driver authorization card is~~ :

22 (a) Expires ~~as provided in regulations adopted by the Department pursuant~~
23 ~~to NRS 483.380,~~ on the fourth anniversary of the holder's birthday, measured in
24 ~~the case of initial issuance or renewal from the birthday nearest the date of~~
25 ~~issuance or renewal.~~

26 (b) Is renewable at any time before its expiration upon application and
27 payment of the required fee. ~~The Department may, by regulation, defer the~~
28 ~~expiration of the driver authorization card of a person who is on active duty in the~~
29 ~~Armed Forces of the United States upon such terms and conditions as it may~~
30 ~~prescribe. The Department may similarly defer the expiration of the driver~~
31 ~~authorization card of the spouse or dependent son or daughter of that person if the~~
32 ~~spouse or child is residing with the person.~~

33 7. A driver authorization card shall not be used to determine eligibility for any
34 benefits, licenses or services issued or provided by this State or its political
35 subdivisions.

36 8. Except as otherwise provided in this section or by specific statute, any
37 provision of this title that applies to drivers' licenses shall be deemed to apply to a
38 driver authorization card and an instruction permit obtained in accordance with this
39 section.

41 ~~— 483.380 1. Except as otherwise provided in NRS 483.283, every driver's~~
42 ~~license and driver authorization card expires as prescribed by regulation.~~

43 ~~— 2. The Department shall adopt regulations prescribing when a driver's license~~
44 ~~expires] and a driver authorization card expire. The Department may, by~~
45 ~~regulation, defer the expiration of the driver's license or driver authorization card~~
46 ~~of a person who is on active duty in the Armed Forces upon such terms and~~
47 ~~conditions as it may prescribe. The Department may similarly defer the expiration~~

2 ~~Vehicles shall adopt the regulations required pursuant to NRS 483.380, as amended~~
3 ~~by section 2 of this act.] **(Deleted by amendment.)**~~
4 **Sec. 4.** This act becomes effective on July 1, 2017.
