SUMMARY—Requires the Department of Health and Human Services to take certain actions to improve access to diapers and diapering supplies for recipients of public assistance. (BDR 38-871)

AN ACT relating to public welfare; requiring the Director of the Department of Health and Human Services to ~~take certain actions~~ **appoint a committee to research opportunities** to improve access to diapers and diapering supplies for recipients of public assistance, ~~and other low-income families; authorizing the Director to take any necessary action to take advantage of opportunities to increase the availability of diapers and diapering supplies to such persons;~~ requiring the Director to work with diaper banks and similar organizations for certain related purposes; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Section 2 of this bill requires the Director of the Department of Health and Human  
 2 Services to appoint a committee to research opportunities ~~to use federal money~~ to increase  
 3 the availability of diapers and diapering supplies to certain recipients of public assistance, ~~and~~  
 4 **and low-income families.** ~~(including, without limitation, researching whether diapers and~~  
 5 ~~diapering supplies may be provided as an incentive to complete certain programs. Such~~  
 6 ~~programs may relate to smoking cessation, prenatal care visits or pediatric follow up~~  
 7 ~~appointments with certain providers of health care.)~~ Section 2 requires the committee ~~to~~  
 8 ~~report to the Director at least two times each year and requires~~ **to consist of representatives**  
 9 **from the Department of Health and Human Services who have knowledge of certain**  
 10 **programs offered by the Department, as well as representatives of organizations located**  
 11 **in this State that provide services relating to diapers and diapering supplies to recipients**  
 12 **of public assistance and other low-income families. Section 2 also requires the committee**  
 13 **to report the results of its research to the Director of the Department on or before June**  
 14 **30 of each year and requires the Director, on or before September 30 of each even-**  
 15 **numbered year, to submit a report of the results of such research and any**  
 16 **recommendations for changes in state laws or regulations to the Legislature. Section 2**  
 17 **authorizes** the Director to take ~~any~~ **any necessary action to increase the availability of**  
 18 **diapers and diapering supplies to certain recipients of public assistance, ~~and~~ and other low-**  
 19 **income families.**  
 20 Section 3 of this bill requires the Director **of the Department** to work collaboratively  
 21 with any diaper banks in this State and any similar nonprofit organizations which provide

22 diapers and diapering supplies to low-income persons at no cost or a reduced cost to ensure  
 23 recipients of public assistance **and other low-income families** are made aware of the  
 24 existence, location and services provided by such organizations. **Section 3** also requires the  
 25 Director to make this information available on the Internet website of the Department and  
 26 with any appropriate informational material which is made available to recipients of public  
 27 assistance to the extent possible.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 422A of NRS is hereby amended by adding thereto the  
 2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2. 1.** ~~The Director shall appoint a committee ~~within the Division~~ to~~  
 4 ~~research opportunities ~~to use money received from the Federal Government~~ to~~

 16 ~~combination thereof, including, without limitation, in-kind donations and~~  
 17 ~~donations from private foundations, manufacturers of diapers and diapering~~

19 **2.** ~~The committee must consist of representatives of:~~

20 ~~(a) The Department who have knowledge of programs offered by the~~  
 21 ~~Department, including, without limitation, programs relating to smoking~~  
 22 ~~cessation, prenatal care visits and follow-up appointments for infants and~~  
 23 ~~children with providers of health care; and~~

24 ~~(b) Organizations located in this State which provide services relating to~~  
 25 ~~diapers and diapering supplies to recipients of public assistance and other low-~~  
 26 ~~income families, including, without limitation, organizations which advocate and~~

28 **3.** ~~The committee must report the results of its research to the Director ~~at~~~~

30 ~~~~3.~~ on or before June 30 of each year. If the Director determines ~~that any~~~~

1       **Sec. 3. 1. The Director shall work collaboratively with any diaper banks**  
2 **in this State and any similar nonprofit organizations which provide diapers and**  
3 **diapering supplies to low-income persons at no cost or a reduced cost to ensure**  
4 **recipients of public assistance and other low-income families are made aware of**  
5 **the existence, location and services provided by such organizations.**

6       **2. The Director shall post the information described in subsection 1 on the**  
7 **Internet website of the Department and shall include such information with**  
8 **materials provided by the Department to recipients of public assistance and other**  
9 **low-income families to the extent possible.**

10       **Sec. 3.5. The provisions of subsection 1 of NRS 218D.380 do not apply to**  
11 **any provision of this act which adds or revises a requirement to submit a**  
12 **report to the Legislature.**

13       **Sec. 4. This act becomes effective on July 1, 2017.**
