AN ACT relating to group homes; requiring the Legislative Committee on Health Care to conduct an interim study concerning the rates ~~charged by~~ **paid by the State to the** group homes ~~in this State.~~ **contracted with Southern Nevada Adult Mental Health Services;** and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires the Legislative Committee on Health Care to conduct an interim study
2 concerning the rates ~~charged by~~ **paid by the State to the** group homes ~~in this State.~~
3 **contracted with Southern Nevada Adult Mental Health Services.** In relevant part, the
4 Committee must review and evaluate the current rates that are ~~charged by~~ **paid by the State**
5 **to the** group homes **contracted with Southern Nevada Adult Mental Health Services** and
6 whether any changes in the rates may be necessary.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. The Legislative Committee on Health Care shall conduct an
2 interim study concerning the rates ~~charged by~~ **paid by the State to the** group
3 homes ~~in this State.~~ **contracted with Southern Nevada Adult Mental Health**
4 **Services.**
5 2. The study must include, without limitation:
6 (a) A comprehensive review and evaluation of the rates ~~charged by~~ **paid by**
7 **the State to the** group homes ~~in this State.~~ **contracted with Southern Nevada**
8 **Adult Mental Health Services** and whether any changes in the rates may be
9 necessary;
10 (b) A comprehensive evaluation of the impact a change in such rates would
11 have on group homes **contracted with Southern Nevada Adult Mental Health**

1 Services as well as on any person who uses the services provided by such group
2 homes; ~~in this State;~~

3 (c) A comprehensive evaluation of state and federal funding for the group
4 homes ~~in this State~~ contracted with Southern Nevada Adult Mental Health
5 Services and the impact a change in the rates ~~charged by~~ paid by the State to
6 such group homes would have on such funding;

7 (d) Consideration of the applicable provisions of federal law; and

8 (e) An examination of any other matter that the Legislative Committee on
9 Health Care determines to be relevant to the study.

10 3. The Legislative Committee on Health Care shall ensure that the persons
11 and entities that manage the group homes contracted with Southern Nevada
12 Adult Mental Health Services or provide services on behalf of group homes ~~in~~
13 ~~this State~~ contracted with Southern Nevada Adult Mental Health Services are
14 involved in the study.

15 4. The Legislative Committee on Health Care shall submit a report of the
16 results of the study conducted pursuant to subsection 2 and any recommendations
17 for legislation to the Director of the Legislative Counsel Bureau for transmission to
18 the 80th Session of the Nevada Legislature.

19 5. As used in this section, "group homes" includes, without limitation, the
20 facilities, homes, houses and institutions ~~described~~ that are:

21 (a) Contracted with Southern Nevada Adult Mental Health Services; and

22 (b) Described in subsection 1 of NRS 244.3549.

23 **Sec. 2.** This act becomes effective on July 1, 2017.
