SUMMARY—~~Requires the issuance, without charge, of an annual pass for state parks and recreational areas to certain persons under certain circumstances.~~ Provides for the issuance of free annual permits to fifth graders to enter state parks and recreational areas. (BDR 35-656)

AN ACT relating to state lands; requiring the Administrator of the Division of State Parks of the State Department of Conservation and Natural Resources to ~~issue,~~ establish a program for the issuance, without charge, ~~of~~ an annual ~~pass~~ permit for state parks and recreational areas to ~~each pupil~~ pupils enrolled in the fifth grade in this State ~~and to each member of his or her immediate family,~~ under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law ~~required~~ sets forth the general authority of the Administrator of the Division of State Parks of the State Department of Conservation and Natural Resources to ~~establish and maintain state parks and recreational areas in this State, including, without limitation, the authority to issue~~ an annual permit ~~for entering, camping and boating in all~~ to a person to enter, camp and boat in those state parks and recreational areas ~~to a person who is 65 years of age or older or has incurred a permanent service-connected disability under certain circumstances.~~ (NRS 407.065) This bill ~~similarly~~ requires the Division Administrator to ~~issue~~ establish a program for the issuance of an annual permit ~~for entering, camping and boating in~~ free of charge, to enter all state parks and recreational areas in this State to any pupil who is enrolled in the fifth grade at a school in this State ~~and to each member of his or her immediate family. Each permit must be issued without charge, including any administrative fee to cover the cost of issuing the permit.~~ This bill further requires that the permit is valid only during the period in which the pupil is ~~enrolled in the fifth grade at a school in this State.~~ The program must include, without limitation, provisions which specify the circumstances under which a pupil and any person accompanying a pupil may use the annual permit to enter a state park or

17 recreational area. This bill also provides that an annual permit issued pursuant to the
18 program authorizes the holder of the permit to enter a state park or recreational area
19 free of charge, but does not authorize camping, boating or attending special events at a
20 state park or recreational area without paying a fee.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 407.065 is hereby amended to read as follows:

2 407.065 1. The Administrator, subject to the approval of the Director:

3 (a) Except as otherwise provided in this paragraph and NRS 407.066, may
4 establish, name, plan, operate, control, protect, develop and maintain state parks,
5 monuments and recreational areas for the use of the general public. The name of an
6 existing state park, monument or recreational area may not be changed unless the
7 Legislature approves the change by statute.

8 (b) Shall protect state parks and property controlled or administered by the
9 Division from misuse or damage and preserve the peace within those areas. The
10 Administrator may appoint or designate certain employees of the Division to have
11 the general authority of peace officers.

12 (c) May allow multiple use of state parks and real property controlled or
13 administered by the Division for any lawful purpose, including, but not limited to,
14 grazing, mining, development of natural resources, hunting and fishing, in
15 accordance with such regulations as may be adopted in furtherance of the purposes
16 of the Division.

17 (d) Except as otherwise provided in this ~~paragraph,~~ section, shall impose and
18 collect reasonable fees for entering, camping and boating in state parks and
19 recreational areas. The Division shall issue an annual permit for entering, camping
20 and boating in all state parks and recreational areas in this State:

21 (1) Upon application therefor and proof of residency and age, to any
22 person who is 65 years of age or older and has resided in this State for at least 5
23 years immediately preceding the date on which the application is submitted.

24 (2) Upon application therefor and proof of residency and proof of status as
25 described in subsection 5 of NRS 361.091, to a bona fide resident of the State of
26 Nevada who has incurred a permanent service-connected disability of 10 percent or
27 more and has been honorably discharged from the Armed Forces of the United
28 States.

29 ~~(3) Upon application therefor and proof of residency, enrollment and
30 family relationship, to any pupil who is enrolled in the fifth grade at a school in
31 this State and to each member of his or her immediate family.]~~

32 → ~~The~~ Each permit must be issued without charge, except that the Division shall
33 charge and collect an administrative fee for the issuance of ~~the~~ each permit
34 ~~pursuant to subparagraph (1) or (2)~~ in an amount sufficient to cover the costs of
35 issuing the permit. ~~Each permit issued pursuant to subparagraph (3) is valid only
36 during the period in which the pupil to whom the Division issues the permit is
37 enrolled in the fifth grade at a school in this State.]~~

38 (e) May conduct and operate such special services as may be necessary for the
39 comfort and convenience of the general public, and impose and collect reasonable
40 fees for such special services.

41 (f) May rent or lease concessions located within the boundaries of state parks
42 or of real property controlled or administered by the Division to public or private
43 corporations, to groups of natural persons, or to natural persons for a valuable

1 consideration upon such terms and conditions as the Division deems fit and proper,
2 but no concessionaire may dominate any state park operation.

3 (g) May establish such capital projects construction funds as are necessary to
4 account for the parks improvements program approved by the Legislature. The
5 money in these funds must be used for the construction and improvement of those
6 parks which are under the supervision of the Administrator.

7 (h) In addition to any concession specified in paragraph (f), may establish
8 concessions within the boundaries of any state park to provide for the sale of food,
9 drinks, ice, publications, sundries, gifts and souvenirs, and other such related items
10 as the Administrator determines are appropriately made available to visitors. Any
11 money received by the Administrator for a concession established pursuant to this
12 paragraph must be deposited in the Account for State Park Interpretative and
13 Educational Programs and Operation of Concessions created by NRS 407.0755.

14 2. The Administrator:

15 (a) Shall issue an annual permit to a person who pays a reasonable fee as
16 prescribed by regulation which authorizes the holder of the permit to enter each
17 state park and each recreational area in this State and, except as otherwise provided
18 in subsection ~~2, 4~~, use the facilities of the state park or recreational area without
19 paying the entrance fee; and

20 (b) May issue an annual permit to a person who pays a reasonable fee as
21 prescribed by regulation which authorizes the holder of the permit to enter a specific
22 state park or specific recreational area in this State and, except as otherwise provided
23 in subsection ~~2, 4~~, use the facilities of the state park or recreational area without
24 paying the entrance fee.

25 3. The Administrator shall establish a program for the issuance of an
26 annual permit, free of charge, to enter each state park and recreational area in
27 this State to any pupil who is enrolled in the fifth grade at a school in this State.
28 The program must:

29 (a) Specify the period for which the Administrator may issue an annual
30 permit to a pupil pursuant to this subsection, including, without limitation, the
31 date upon which the Administrator may issue an annual permit to a pupil who
32 has completed fourth grade and who intends to enter the fifth grade after
33 completing the fourth grade;

34 (b) Specify the circumstances under which a pupil and any person
35 accompanying a pupil may use the annual permit to enter a state park or
36 recreational area; and

37 (c) Include any other requirement which the Administrator determines is
38 necessary to establish and carry out the program pursuant to this subsection.

39 4. An annual permit issued pursuant to subsection 2 or 3 does not authorize
40 the holder of the permit to engage in camping or boating, or to attend special
41 events. The holder of such a permit who wishes to engage in camping or boating, or
42 to attend special events, must pay any fee established for the respective activity.

43 4. ~~4~~ Except as otherwise provided in subsection 1 of NRS 407.0762 and
44 subsection 1 of NRS 407.0765, the fees collected pursuant to paragraphs (d), (e)
45 and (f) of subsection 1 or subsection 2 must be deposited in the State General Fund.

46 Sec. 2. This act becomes effective upon passage and approval for the purpose
47 of performing any administrative tasks that are necessary to carry out the provisions
48 of this act and on July 1, 2017, for all other purposes.
