AN ACT relating to land use planning; setting forth legislative findings and declarations concerning certain changes in zoning and development standards; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill: (1) sets forth legislative findings relating to proposed changes in zoning and
2 hillside development standards on the undeveloped lands adjacent to the Sunrise and
3 Frenchman Mountains; and (2) declares that it is consistent with the Legislature’s intent ~~that~~
4 for the Board of Commissioners of Clark County ~~maintain~~ to strengthen, as necessary to
5 promote responsible development and preserve important natural resources, the existing
6 zoning and hillside development standards on the undeveloped desert lands adjacent to the
7 western faces of Sunrise and Frenchman Mountains.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. The Legislature hereby finds that:
2 (a) Sunrise Mountain and Frenchman Mountain are undeveloped natural
3 treasures adjacent to the Las Vegas Valley;
4 (b) The Bureau of Land Management has designated over 10,000 acres of land
5 encompassing Sunrise and Frenchman Mountains as the Sunrise Mountain Instant
6 Study Area;
7 (c) The Sunrise Mountain Instant Study Area is located approximately 8 miles
8 east of downtown Las Vegas and provides a close and convenient natural mountain
9 xeriscape for the residents of southern Nevada;

1 (d) The Sunrise Mountain Instant Study Area has the Nellis Air Force Base as
2 its neighbor to the north and has easy access to visitors provided by State Route
3 147;

4 (e) With an elevation variance of nearly 2,000 feet, the Sunrise Mountain
5 Instant Study Area is home to several colorful mountain ranges rising up from the
6 desert lowlands of urban eastern Las Vegas and eastern unincorporated Clark
7 County;

8 (f) In the northeastern corner of the Sunrise Mountain Instant Study Area,
9 Gypsum Cave holds some of the earliest evidence of human inhabitation in the
10 western United States;

11 (g) The Great Unconformity provides the opportunity for southern Nevada
12 geologists and students to view and study an exposed surface of rock that represents
13 more than one quarter of the history (1.2 billion years) of the Earth's crust and
14 tectonic plates;

15 (h) Low desert scrub covers the Sunrise Mountain Instant Study Area and
16 several plant species live within the area that have received special status
17 designation by the Bureau of Land Management;

18 (i) Many residents who live adjacent to Sunrise and Frenchman Mountains
19 decided to live there because they like being somewhat close to urban Las Vegas,
20 and yet also being able to enjoy the peace and quiet of living on the edge of the
21 undeveloped desert in the foothills of Sunrise and Frenchman Mountains;

22 (j) Many residents of Nevada enjoy the natural desert landscape of and outdoor
23 recreational opportunities provided by Sunrise and Frenchman Mountains,
24 including, without limitation, hiking, climbing, camping, rockhounding and bird-
25 watching;

26 (k) Developers are planning large-scale developments on previously
27 undeveloped lands adjacent to the western faces of Sunrise and Frenchman
28 Mountains;

29 (l) These developers are pursuing zoning changes and waivers of established
30 hillside development standards to increase the density of potential developments on
31 the undeveloped lands adjacent to Sunrise and Frenchman Mountains; and

32 (m) Neighbors have expressed grave concerns about the impact any potential
33 zoning changes and waivers of hillside development standards will have on their
34 quality of life, including, without limitation, impacts on traffic, parks, schools,
35 police and fire services, demand for water and flood control and potential negative
36 environmental impacts on this state treasure.

37 2. The Legislature hereby declares that it is consistent with the Legislature's
38 intent ~~that~~ for the Board of Commissioners of Clark County ~~maintain~~ to
39 strengthen, as necessary to promote responsible development and preserve
40 important natural resources, the existing zoning and hillside development
41 standards on the undeveloped desert lands adjacent to the western faces of Sunrise
42 Mountain and Frenchman Mountain.

43 **Sec. 2.** This act becomes effective upon passage and approval.
