AN ACT making appropriations to the Department of Education for incentives for hiring new teachers ~~and incentives for teachers employed~~ to teach at Title I schools and schools designated as underperforming ~~and~~ and incentives for certain teachers who transfer to teach at those schools; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Department of Education to provide incentives for the hiring of new teachers ~~to~~ to teach at Title I schools or schools that are designated as underperforming pursuant to the statewide system of accountability for public schools, the sum
3 of \$2,500,000.

4 2. There is hereby appropriated from the State General Fund to the
5 Department of Education to provide incentives for teachers who are currently
6 employed to teach at a public school in Nevada that is not a Title I school or ~~not~~ a
7 school ~~that is~~ designated as underperforming pursuant to the statewide system of
8 accountability for public schools ~~and who transfer to teach at a Title I school~~
9 or a school with that designation, the sum of \$2,500,000.

10 3. The State Board of Education shall adopt regulations as necessary to carry out the provisions of this section.

11 4. As used in this section, “Title I school” has the meaning ascribed to it in
12 NRS 385A.040.

13 **Sec. 2.** Any remaining balance of the appropriations made by section 1 of
14 this act must not be committed for expenditure after June 30, 2019, by the entity to
15 which the appropriation is made or any entity to which money from the
16 appropriation is granted or otherwise transferred in any manner, and any portion of
17 the appropriated money remaining must not be spent for any purpose after
18 June 30, 2020.

1 September 20, 2019, by either the entity to which the money was appropriated or
2 the entity to which the money was subsequently granted or transferred, and must be
3 reverted to the State General Fund on or before September 20, 2019.

4 **Sec. 3.** This act becomes effective on July 1, 2017.
