AN ACT making an appropriation to the Account for Pensions for Silicosis, Diseases Related to Asbestos and Other Disabilities; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** There is hereby appropriated from the State General Fund to the  
2 Account for Pensions for Silicosis, Diseases Related to Asbestos and Other  
3 Disabilities created by NRS 617.1675 the sum of \$80,000.

4       **Sec. 2.** ~~[Any remaining balance of the appropriation made by section 1 of this  
5 act must not be committed for expenditure after June 30, 2019, by the entity to  
6 which the appropriation is made or any entity to which money from the  
7 appropriation is granted or otherwise transferred in any manner, and any portion of  
8 the appropriated money remaining must not be spent for any purpose after  
September 20, 2019, by either the entity to which the money was appropriated or  
the entity to which the money was subsequently granted or transferred, and must be  
reverted to the State General Fund on or before September 20, 2019.]~~ **(Deleted by  
12 amendment.)**

13       **Sec. 3.** This act becomes effective ~~[on July 1, 2017.]~~ **upon passage and  
14 approval.**
