AN ACT making appropriations to the Department of Corrections for a new telephone system and for certain information system projects; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Department of Corrections the sum of \$2,339,477 for an electronic medical
3 records system to store inmate medical records and interface with the Department's
4 offender management system and other vendor software systems.

5 2. There is hereby appropriated from the State General Fund to the
6 Department of Corrections the sum of \$1,285,440 for the continuation of the
7 transition from the Nevada Offender Tracking Information System to a new internal
8 system.

9 3. There is hereby appropriated from the State General Fund to the
10 Department of Corrections the sum of \$2,263,231 for the installation of a new
11 telephone system for the Department.

12 4. There is hereby appropriated from the State General Fund to the
13 Department of Corrections the sum of \$637,085 for the replacement of the Nevada
14 Staffing Information System used to schedule correctional officers.

15 **Sec. 2.** Any remaining balance of the appropriations made by section 1 of
16 this act must not be committed for expenditure after June 30, 2019, by the entity to
17 which the appropriation is made or any entity to which money from the
18 appropriation is granted or otherwise transferred in any manner, and any portion of
19 the appropriated money remaining must not be spent for any purpose after
20 September 20, 2019, by either the entity to which the money was appropriated or
21 the entity to which the money was subsequently granted or transferred, and must be
22 reverted to the State General Fund on or before September 20, 2019.

1 **Sec. 3.** This act becomes effective ~~on July 1, 2017.~~ upon passage and
2 approval.
