AN ACT making appropriations to the Department of Public Safety for the replacement of vehicles, pickup trucks and motorcycles for the Nevada Highway Patrol; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State Highway Fund to
2 the Department of Public Safety the sum of \$8,531,643 for the replacement of
3 vehicles and pickup trucks for the Nevada Highway Patrol.

4 2. There is hereby appropriated from the State Highway Fund to the
5 Department of Public Safety the sum of \$385,252 for the replacement of
6 motorcycles for the Nevada Highway Patrol.

7 **Sec. 2.** Any remaining balance of the appropriations made by section 1 of
8 this act must not be committed for expenditure after June 30, 2019, by the entity to
9 which the appropriation is made or any entity to which money from the
10 appropriation is granted or otherwise transferred in any manner, and any portion of
11 the appropriated money remaining must not be spent for any purpose after
12 September 20, 2019, by either the entity to which the money was appropriated or
13 the entity to which the money was subsequently granted or transferred, and must be
14 reverted to the State Highway Fund on or before September 20, 2019.

15 **Sec. 3.** This act becomes effective **[on July 1, 2017.]** **upon passage and**
16 **approval.**
