AN ACT relating to health care; creating the State of Nevada Advisory Council on Palliative Care and Quality of Life; authorizing the Council to apply for and accept certain money; establishing the Palliative Care and Quality of Life Consumer and Professional Information and Education Program within the Department of Health and Human Services; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

**Sections 7 and 8** of this bill create the State of Nevada Advisory Council on Palliative Care and Quality of Life within the Department of Health and Human Services and prescribe the qualifications and duties of members of the Council. **Section 9** of this bill authorizes the Council to apply for grants and accept gifts, grants, appropriations or donations. **Section 10** of this bill establishes the Palliative Care and Quality of Life Consumer and Professional Information and Education Program within the Department. **Section 12** of this bill requires the Director of the Department to encourage hospitals, assisted living facilities and facilities for skilled nursing with 100 beds or more to educate their physicians, nurses and *clinical* staff members regarding palliative care and provide information to patients or residents regarding palliative care.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** Chapter 232 of NRS is hereby amended by adding thereto the provisions set forth as sections 2 to 10, inclusive, of this act.

**Sec. 2.** *As used in sections 2 to 10, inclusive, of this act, unless the context otherwise requires, the words and terms defined in sections 3 to 6, inclusive, of this act have the meanings ascribed to them in those sections.*

**Sec. 3.** *“Council” means the State of Nevada Advisory Council on Palliative Care and Quality of Life created by section 7 of this act.*

**Sec. 4.** *“Palliative care” means a multidisciplinary and patient- and family-centered approach to specialized medical care for a person with a serious illness,*

1 *which approach focuses on the care of a patient throughout the continuum of an*  
2 *illness and involves addressing the physical, emotional, social and spiritual needs*  
3 *of the patient, as well as facilitating patient autonomy, access to information and*  
4 *choice of care. The term includes, without limitation, discussion of the goals of*  
5 *the patient for treatment and discussion of treatment options appropriate to the*  
6 *patient, including, where appropriate, hospice care and comprehensive*  
7 *management of pain and symptoms.*

8 **Sec. 5. “Program” means the Palliative Care and Quality of Life**  
9 **Consumer and Professional Information and Education Program established by**  
10 **section 10 of this act.**

11 **Sec. 6. “Serious illness” means a medical illness, physical injury or**  
12 **condition that substantially affects the quality of life of a person for more than a**  
13 **short period of time. A serious illness includes, without limitation, Alzheimer’s**  
14 **disease and related dementias, cancer, lung disease, heart, renal or liver failure**  
15 **and similar conditions or diseases.**

16 **Sec. 7. 1. The State of Nevada Advisory Council on Palliative Care and**  
17 **Quality of Life is hereby created within the Department.**

18 **2. The Director shall appoint such number of members of the Council as he**  
19 **or she determines is appropriate to carry out the provisions of sections 2 to 10,**  
20 **inclusive, of this act, but not less than nine members as follows:**

21 **(a) Two members with experience in the provision of interdisciplinary**  
22 **palliative care, including, without limitation, hospital, medical, nursing, social**  
23 **work, pharmacy, financial and spiritual services;**

24 **(b) One member with a background in patient and family caregiver**  
25 **advocacy;**

26 **(c) One member who is a health care professional with clinical experience in**  
27 **palliative care;**

28 **(d) One member who is a health care professional with expertise in delivery**  
29 **models for palliative care in a variety of inpatient, outpatient and community**  
30 **settings and with diverse populations;**

31 **(e) Two members who are employees of the Department or any other state**  
32 **agency, board or commission who have relevant work experience related to**  
33 **palliative care and issues concerning quality of life; and**

34 **(f) Two members who are board certified hospice and palliative care**  
35 **physicians or nurses.**

36 **3. After the initial terms, the term of each member of the Council is 3 years,**  
37 **and members shall serve at the pleasure of the Director.**

38 **4. The Council shall select from its members a Chair and a Vice Chair who**  
39 **shall hold office for 1 year and whose duties will be established by the Council.**

40 **5. The Council shall meet at least twice annually at a time and place**  
41 **specified by a call of the Director.**

42 **6. Each member of the Council:**

43 **(a) Serves without compensation; and**

44 **(b) While engaged in the business of the Council, is entitled to receive the per**  
45 **diem allowance and travel expenses provided for state officers and employees**  
46 **generally to the extent that funds for such expenses are available within the**  
47 **budget of the Department.**

48 **Sec. 8. The Council shall:**

49 **1. Consult with and advise the Department on matters related to the**  
50 **establishment, maintenance, operation and outcomes of palliative care programs**  
51 **and initiatives in this State; and**

52 **2. Advise and assist in the creation and carrying out of the Program**  
53 **established by section 10 of this act.**

1       **Sec. 9.** *The Council may apply for any available grants and accept any*  
2 *available gifts, grants, appropriations or donations, and use any such gifts,*  
3 *grants, appropriations or donations to carry out the provisions of sections 2 to 10,*  
4 *inclusive, of this act.*

5       **Sec. 10.** *1. The Palliative Care and Quality of Life Consumer and*  
6 *Professional Information and Education Program is hereby established within*  
7 *the Department to maximize the effectiveness of palliative care initiatives in this*  
8 *State by ensuring that comprehensive and accurate information and education*  
9 *about palliative care is available to health care providers, health care facilities*  
10 *and members of the public.*

11       **2.** *The Department shall ,to the extent that money is available from gifts,*  
12 *grants, appropriations and donations for this purpose, include on an Internet*  
13 *website available to the public, with links to appropriate external Internet*  
14 *websites, information and resources concerning:*

15       *(a) The delivery of palliative care in the home and in primary, secondary and*  
16 *tertiary environments;*

17       *(b) Best practices for the delivery of palliative care; and*

18       *(c) Educational materials and referral information for palliative and hospice*  
19 *care.*

20       **3.** *The Department may develop and carry out such other initiatives*  
21 *regarding palliative care and education that the Department determines will*  
22 *further the purposes of the Program. The Director shall consult with the Council*  
23 *in developing and implementing such initiatives.*

24       **Sec. 11.** NRS 232.290 is hereby amended to read as follows:

25       232.290 As used in NRS 232.290 to 232.484, inclusive, *and sections 2 to 10,*  
26 *inclusive, of this act,* unless the context requires otherwise:

27       1. "Department" means the Department of Health and Human Services.

28       2. "Director" means the Director of the Department.

29       **Sec. 12.** *1. On or before January 1, 2018, the Department of Health and*  
30 *Human Services shall encourage all hospitals, assisted living facilities and facilities*  
31 *for skilled nursing within this State with 100 beds or more to:*

32       *(a) Educate their physicians, nurses and clinical staff on how to provide*  
33 *information regarding appropriate palliative care; and*

34       *(b) Provide information about, and facilitate access to, appropriate palliative*  
35 *care.*

36       2. As used in this section:

37       *(a) "Assisted living facility" has the meaning ascribed to it in NRS 422.3962;*  
38 *and*

39       *(b) "Facility for skilled nursing" has the meaning ascribed to it in NRS*  
40 *449.0039.*

41       **Sec. 13.** *1. Not later than October 1, 2017, the Director of the Department*  
42 *of Health and Human Services shall appoint the members of the State of Nevada*  
43 *Advisory Council on Palliative Care and Quality of Life created by section 7 of this*  
44 *act to initial terms as follows:*

45       *(a) Three members whose terms expire on September 30, 2018:*

46       *(1) One of whom must be appointed pursuant to paragraph (a) of*  
47 *subsection 2 of section 7 of this act;*

48       *(2) One of whom must be appointed pursuant to paragraph (b) of*  
49 *subsection 2 of section 7 of this act; and*

50       *(3) One of whom must be appointed pursuant to paragraph (c) of*  
51 *subsection 2 of section 7 of this act.*

52       *(b) Three members whose terms expire on September 30, 2019:*

1 (1) One of whom must be appointed pursuant to paragraph (a) of  
2 subsection 2 of section 7 of this act;

3 (2) One of whom must be appointed pursuant to paragraph (e) of  
4 subsection 2 of section 7 of this act; and

5 (3) One of whom must be appointed pursuant to paragraph (f) of  
6 subsection 2 of section 7 of this act.

7 (c) Three members whose terms expire on September 30, 2020:

8 (1) One of whom must be appointed pursuant to paragraph (d) of  
9 subsection 2 of section 7 of this act;

10 (2) One of whom must be appointed pursuant to paragraph (e) of  
11 subsection 2 of section 7 of this act; and

12 (3) One of whom must be appointed pursuant to paragraph (f) of  
13 subsection 2 of section 7 of this act.

14 2. If more than nine members are appointed to the Council, the Director shall,  
15 at his or her sole discretion, determine the allocation of the additional members  
16 appointed to the Council to the particular groupings established for the expiration of  
17 terms in subsection 1.

18 **Sec. 14.** This act becomes effective on July 1, 2017.
