SUMMARY—Makes appropriations to the Division of Welfare and Supportive Services of the Department of Health and Human Services for certain information system projects and authorizes the expenditure of certain money for such purposes. (BDR S-1198)

AN ACT making appropriations to the Division of Welfare and Supportive Services of the Department of Health and Human Services for certain information system projects; authorizing the expenditure of certain money by the Division for such purposes; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State General Fund to the Division of Welfare and Supportive Services of the Department of Health and Human Services the sum of \$127,500 for a master client index to develop a cross index of all databases of the Department.

2. Expenditure of \$1,147,500 not appropriated from the State General Fund or the State Highway Fund is hereby authorized during Fiscal Year 2017-2018 and Fiscal Year 2018-2019 by the Division for the same purpose as set forth in subsection 1.

Sec. 2. 1. There is hereby appropriated from the State General Fund to the Division of Welfare and Supportive Services of the Department of Health and Human Services the sum of \$1,000,000 for modernization of Access Nevada to provide clients of the Division with the opportunity to submit electronic applications for Medicaid, the Supplemental Nutrition Assistance program and Temporary Assistance for Needy Families.

2. Expenditure of \$9,000,000 not appropriated from the State General Fund or the State Highway Fund is hereby authorized during Fiscal Year 2017-2018 and Fiscal Year 2018-2019 by the Division for the same purpose as set forth in subsection 1.

Sec. 3. 1. There is hereby appropriated from the State General Fund to the Division of Welfare and Supportive Services of the Department of Health and

1 Human Services the sum of \$407,673 for a case management system to allow for
2 the “no wrong door” approach to serving clients throughout the Department.

3 2. Expenditure of \$3,458,225 not appropriated from the State General Fund or
4 the State Highway Fund is hereby authorized during Fiscal Year 2017-2018 and
5 Fiscal Year 2018-2019 by the Division for the same purpose as set forth in
6 subsection 1.

7 **Sec. 4.** 1. There is hereby appropriated from the State General Fund to the
8 Division of Welfare and Supportive Services of the Department of Health and
9 Human Services the sum of \$9,304,699 for the second phase to modernize the
10 automated processing system for the child support enforcement program.

11 2. Expenditure of \$20,120,886 not appropriated from the State General Fund
12 or the State Highway Fund is hereby authorized during Fiscal Year 2017-2018 and
13 Fiscal Year 2018-2019 by the Division for the same purpose as set forth in
14 subsection 1.

15 **Sec. 5.** Any remaining balance of the appropriations made by sections 1 to 4,
16 inclusive, of this act must not be committed for expenditure after June 30, 2019, by
17 the entity to which the appropriation is made or any entity to which money from the
18 appropriation is granted or otherwise transferred in any manner, and any portion of
19 the appropriated money remaining must not be spent for any purpose after
20 September 20, 2019, by either the entity to which the money was appropriated or
21 the entity to which the money was subsequently granted or transferred, and must be
22 reverted to the State General Fund on or before September 20, 2019.

23 **Sec. 6.** This act becomes effective ~~on July 1, 2017,~~ upon passage and
24 approval.
