AN ACT relating to crimes; enhancing the criminal penalty for certain crimes committed against first responders; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Section 1** of this bill provides that any person who willfully commits certain crimes
2 because of the fact that the victim is a first responder, which **section 1** defines as any peace
3 officer, firefighter or emergency medical provider acting in the normal course of duty, may, in
4 addition to the term of imprisonment prescribed by statute for the crime, be punished by
5 imprisonment in the state prison for a minimum term of not less than 1 year and a maximum
6 term of not more than 20 years.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 193 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 ***1. Except as otherwise provided in NRS 193.169, any person who willfully***
4 ***violates any provision of NRS 200.030, 200.050, 200.280, 200.310, 200.366,***
5 ***200.380, 200.400, 200.460, NRS 200.471 which is punishable as a felony, NRS***
6 ***200.481 which is punishable as a felony, NRS 205.0832 which is punishable as a***
7 ***felony, NRS 205.220, 205.226, 205.228, 205.270 or 206.150 because of the fact***
8 ***that the victim is a first responder may, in addition to the term of imprisonment***

1 prescribed by statute for the crime, be punished by imprisonment in the state
2 prison for a minimum term of not less than 1 year and a maximum term of not
3 more than 20 years. In determining the length of any additional penalty imposed,
4 the court shall consider the following information:

- 5 (a) The facts and circumstances of the crime;
- 6 (b) The criminal history of the person;
- 7 (c) The impact of the crime on any victim;
- 8 (d) Any mitigating factors presented by the person; and
- 9 (e) Any other relevant information.

10 ↳ The court shall state on the record that it has considered the information
11 described in paragraphs (a) to (e), inclusive, in determining the length of any
12 additional penalty imposed.

13 2. A sentence imposed pursuant to this section:

- 14 (a) Must not exceed the sentence imposed for the crime; and
- 15 (b) Runs consecutively with the sentence prescribed by statute for the crime.

16 3. This section does not create a separate offense but provides an additional
17 penalty for the primary offense, whose imposition is contingent upon the finding
18 of the prescribed fact.

19 4. As used in this section, "first responder" means any peace officer,
20 firefighter or emergency medical provider acting in the normal course of duty. As
21 used in this subsection:

22 (a) "Emergency medical provider" has the meaning ascribed to it in NRS
23 450B.199.

24 (b) "Firefighter" has the meaning ascribed to it in NRS 450B.071.

25 (c) "Peace officer" has the meaning ascribed to it in NRS 169.125.

26 Sec. 2. NRS 193.169 is hereby amended to read as follows:

27 193.169 1. A person who is sentenced to an additional term of
28 imprisonment pursuant to the provisions of subsection 1 of NRS 193.161, NRS
29 193.162, 193.163, 193.165, 193.166, 193.167, 193.1675, 193.168, subsection 1 of
30 NRS 193.1685, NRS 453.3335, 453.3345, 453.3351 or subsection 1 of NRS
31 453.3353 or section 1 of this act must not be sentenced to an additional term of
32 imprisonment pursuant to any of the other listed sections even if the person's
33 conduct satisfies the requirements for imposing an additional term of imprisonment
34 pursuant to another one or more of those sections.

35 2. A person who is sentenced to an alternative term of imprisonment pursuant
36 to subsection 3 of NRS 193.161, subsection 3 of NRS 193.1685 or subsection 2 of
37 NRS 453.3353 must not be sentenced to an additional term of imprisonment
38 pursuant to subsection 1 of NRS 193.161, NRS 193.162, 193.163, 193.165,
39 193.166, 193.167, 193.1675, 193.168, 453.3335, 453.3345 or 453.3351 or section 1
40 of this act even if the person's conduct satisfies the requirements for imposing an
41 additional term of imprisonment pursuant to another one or more of those sections.

42 3. This section does not:

43 (a) Affect other penalties or limitations upon probation or suspension of a
44 sentence contained in the sections listed in subsection 1 or 2.

45 (b) Prohibit alleging in the alternative in the indictment or information that the
46 person's conduct satisfies the requirements of more than one of the sections listed
47 in subsection 1 or 2 and introducing evidence to prove the alternative allegations.

48 Sec. 3. The amendatory provisions of this act apply to an offense committed
49 on or after October 1, 2017.
