SUMMARY—Establishes requirements for engaging in the collaborative practice of pharmacy. (BDR 54-973)

AN ACT relating to pharmacists; authorizing a pharmacist who has entered into a valid collaborative practice agreement to engage in the collaborative practice of pharmacy and collaborative drug therapy management under certain conditions; requiring a pharmacist who engages in the collaborative practice of pharmacy to maintain certain records; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law authorizes a pharmacist to implement, monitor and modify drug
2 therapy pursuant to written guidelines developed by the pharmacist in collaboration
3 with a practitioner. (NRS 639.2809) **Section 4** of this bill authorizes a pharmacist to
4 engage in the collaborative practice of pharmacy or collaborative drug therapy
5 management pursuant to a collaborative practice agreement entered into with one or
6 more practitioners who practice within 100 miles of the primary location where the
7 pharmacist practices in this State. **Section 3** of this bill defines the term
8 “collaborative practice of pharmacy” to mean the performance of tests to address
9 chronic diseases and public health issues. **Section 1.5** of this bill defines the term
10 “collaborative drug therapy management” to mean the initiating, monitoring,
11 modifying or discontinuing of a patient’s drug therapy. **Section 4** requires a
12 practitioner to agree to obtain the informed, written consent of his or her patients
13 that are referred to a pharmacist pursuant to a collaborative practice agreement for
14 collaborative drug therapy management. **Section 4** also requires a pharmacist who
15 engages in the collaborative practice of pharmacy pursuant to a collaborative
16 practice agreement to keep certain records and obtain the informed, written consent
17 of his or her patients. **Section 5** of this bill prescribes the contents and duration of a
18 collaborative practice agreement. **Section 8** of this bill clarifies that the activities

19 authorized by this bill constitute the practice of pharmacy. Sections 7 and 9-11 of
20 this bill make conforming changes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 639 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 1.5 to 6, inclusive, of this
3 act.

4 **Sec. 1.5.** *“Collaborative drug therapy management” means*
5 *initiating, monitoring, modifying or discontinuing a patient’s drug*
6 *therapy by one or more pharmacists under the supervision of one*
7 *or more practitioners in accordance with a collaborative practice*
8 *agreement.*

9 **Sec. 2.** *“Collaborative practice agreement” means an*
10 *agreement that meets the requirements of section 5 of this act*
11 *between one or more pharmacists and one or more practitioners*
12 *which authorizes a pharmacist to engage in the collaborative*
13 *practice of pharmacy or collaborative drug therapy management.*

14 **Sec. 3.** *“Collaborative practice of pharmacy” means the*
15 *performance of tests to address chronic diseases and public health*
16 *issues, including, without limitation, outbreaks and occurrences of*
17 *specific diseases and disorders, by one or more pharmacists in*
18 *collaboration with one or more practitioners in accordance with a*
19 *collaborative practice agreement.*

20 **Sec. 4.** *1. Except as otherwise provided in subsection 5, a*
21 *pharmacist who has entered into a valid collaborative practice*
22 *agreement may engage in the collaborative practice of pharmacy*
23 *or collaborative drug therapy management at any location in this*
24 *State.*

25 *2. To enter into a collaborative practice agreement, a*
26 *practitioner must:*

27 *(a) Be licensed in good standing to practice his or her*
28 *profession in this State;*

29 *(b) Agree to maintain an ongoing relationship with a patient*
30 *who is referred by the practitioner to a pharmacist pursuant to a*
31 *collaborative practice agreement for collaborative drug therapy*
32 *management;*

33 *(c) Agree to obtain the informed, written consent from a*
34 *patient who is referred by the practitioner to a pharmacist*
35 *pursuant to a collaborative practice agreement for collaborative*
36 *drug therapy management; and*

37 *(d) Except as otherwise provided in this paragraph, actively*
38 *practice his or her profession within 100 miles of the primary*



1 *location where the collaborating pharmacist practices in this*
2 *State. A practitioner and pharmacist may submit a written request*
3 *to the Board for an exemption from the requirements of this*
4 *paragraph. The Board may grant such a request upon a showing*
5 *of good cause.*

6 *3. A pharmacist who engages in the collaborative practice of*
7 *pharmacy shall:*

8 *(a) Except as otherwise provided in paragraph (b), document*
9 *any treatment or care provided to a patient pursuant to a*
10 *collaborative practice agreement after providing such treatment or*
11 *care in the medical record of the patient, on the chart of the*
12 *patient or in a separate log book;*

13 *(b) Document in the medical record of the patient, on the chart*
14 *of the patient or in a separate log book any decision or action*
15 *concerning the management of drug therapy pursuant to a*
16 *collaborative practice agreement after making such a decision or*
17 *taking such an action;*

18 *(c) Maintain all records concerning the care or treatment*
19 *provided to a patient pursuant to a collaborative practice*
20 *agreement in written or electronic form for at least 7 years;*

21 *(d) Comply with all provisions of the Health Insurance*
22 *Portability and Accountability Act of 1996, Public Law 104-191,*
23 *the regulations adopted pursuant thereto, and all other federal and*
24 *state laws and regulations concerning the privacy of information*
25 *regarding health care; and*

26 *(e) Provide a patient with written notification of:*

27 *(1) Any test administered by the pharmacist and the results*
28 *of such a test;*

29 *(2) The name of any drug or prescription filled and*
30 *dispensed by the pharmacist to the patient; and*

31 *(3) The contact information of the pharmacist.*

32 *4. A pharmacist shall obtain the informed, written consent of*
33 *a patient before engaging in the collaborative practice of*
34 *pharmacy on behalf of the patient. Such written consent must*
35 *include, without limitation, a statement that the pharmacist:*

36 *(a) May initiate, modify or discontinue the medication of the*
37 *patient pursuant to a collaborative practice agreement;*

38 *(b) Is not a physician, osteopathic physician, advanced*
39 *practice registered nurse or physician assistant; and*

40 *(c) May not diagnose.*

41 *5. A practitioner may not enter into a collaborative practice*
42 *agreement with a pharmacist for the management of controlled*
43 *substances.*



6. *A pharmacy must not require a registered pharmacist, as a condition of employment, to enter into a collaborative practice agreement.*

Sec. 5. 1. *A collaborative practice agreement must be signed by each practitioner and pharmacist who enter into the agreement and submitted to the Board in written and electronic form. A collaborative practice agreement must include:*

(a) *A description of the types of decisions concerning the management of drug therapy that the pharmacist is authorized to make, which may include a specific description of the diseases and drugs for which the pharmacist is authorized to manage drug therapy;*

(b) *A detailed explanation of the procedures that the pharmacist must follow when engaging in the collaborative practice of pharmacy, including, without limitation, the manner in which the pharmacist must document decisions concerning treatment and care in accordance with subsection 3 of section 4 of this act, report such decisions to the practitioner and receive feedback from the practitioner;*

(c) *The procedure by which the pharmacist will notify the practitioner of an adverse event concerning the health of the patient;*

(d) *The procedure by which the practitioner will provide the pharmacist with a diagnosis of the patient and any other medical information necessary to carry out the patient's drug therapy management.*

(e) *A description of the means by which the practitioner will monitor clinical outcomes of a patient and intercede when necessary to protect the health of the patient or accomplish the goals of the treatment prescribed for the patient;*

(f) *Authorization for the practitioner to override the agreement if necessary to protect the health of the patient or accomplish the goals of the treatment prescribed for the patient;*

(g) *Authorization for either party to terminate the agreement by written notice to the other party, which must include, without limitation, written notice to the patient that informs the patient of the procedures by which he or she may continue drug therapy;*

(h) *The effective date of the agreement;*

(i) *The date by which a review must be conducted pursuant to subsection 2 for the renewal of the agreement, which must not be later than the expiration date of the agreement;*

(j) *The address of the location where the records described in subsection 3 of section 4 of this act will be maintained; and*



1 (k) *The process by which the pharmacist will obtain the*
2 *informed, written consent required by subsection 4 of section 4 of*
3 *this act.*

4 2. *A collaborative practice agreement must expire not later*
5 *than 1 year after the date on which the agreement becomes*
6 *effective. The parties to a collaborative practice agreement may*
7 *renew the agreement after reviewing the agreement and making*
8 *any necessary revisions.*

10 Sec. 7. NRS 639.001 is hereby amended to read as follows:

11 639.001 As used in this chapter, unless the context otherwise
12 requires, the words and terms defined in NRS 639.0015 to 639.016,
13 inclusive, *and sections 1.5, 2 and 3 of this act* have the meanings
14 ascribed to them in those sections.

15 Sec. 8. NRS 639.0124 is hereby amended to read as follows:

16 639.0124 "Practice of pharmacy" includes, but is not limited
17 to, the:

18 1. Performance or supervision of activities associated with
19 manufacturing, compounding, labeling, dispensing and distributing
20 of a drug, including the receipt, handling and storage of
21 prescriptions and other confidential information relating to patients.

22 2. Interpretation and evaluation of prescriptions or orders for
23 medicine.

24 3. Participation in drug evaluation and drug research.

25 4. Advising of the therapeutic value, reaction, drug interaction,
26 hazard and use of a drug.

27 5. Selection of the source, storage and distribution of a drug.

28 6. Maintenance of proper documentation of the source, storage
29 and distribution of a drug.

30 7. Interpretation of clinical data contained in a person's record
31 of medication.

32 8. Development of written guidelines and protocols in
33 collaboration with a practitioner which are intended for a patient in a
34 licensed medical facility or in a setting that is affiliated with a
35 medical facility where the patient is receiving care and which
36 authorize ~~the implementation, monitoring and modification of drug~~
37 ~~therapy.~~ *collaborative drug therapy management.* The written
38 guidelines and protocols must comply with NRS 639.2809.

39 9. Implementation and modification of drug therapy ,
40 *administering drugs and ordering and performing tests* in
41 accordance with ~~the authorization of the prescribing practitioner for~~
42 ~~a patient in a pharmacy in which drugs, controlled substances,~~
43 ~~poisons, medicines or chemicals are sold at retail.~~ *a collaborative*

1 ➤ The term does not include the changing of a prescription by a
2 pharmacist or practitioner without the consent of the prescribing
3 practitioner, except as otherwise provided in NRS 639.2583.

4 **Sec. 9.** NRS 639.230 is hereby amended to read as follows:

5 639.230 1. A person operating a business in this State shall
6 not use the word “drug” or “drugs,” “prescription” or “pharmacy,”
7 or similar words or words of similar import, without first having
8 secured a license from the Board. A person operating a business in
9 this State which is not otherwise subject to the provisions of this
10 chapter shall not use the letters “Rx” or “RX” without the approval
11 of the Board. The Board may deny approval of the use of the letters
12 “Rx” or “RX” by any person if the Board determines that:

13 (a) The person is subject to the provisions of this chapter but has
14 not secured a license from the Board; or

15 (b) The use of the letters “Rx” or “RX” by the person is
16 confusing or misleading to or threatens the health or safety of the
17 residents of this State.

18 2. Each license must be issued to a specific person and for a
19 specific location and is not transferable. The original license must be
20 displayed on the licensed premises as provided in NRS 639.150.
21 The original license and the fee required for reissuance of a license
22 must be submitted to the Board before the reissuance of the license.

23 3. If the owner of a pharmacy is a partnership or corporation,
24 any change of partners or corporate officers must be reported to the
25 Board at such a time as is required by a regulation of the Board.

26 4. Except as otherwise provided in subsection 6, in addition to
27 the requirements for renewal set forth in NRS 639.180, every person
28 holding a license to operate a pharmacy must satisfy the Board that
29 the pharmacy is conducted according to law.

30 5. Any violation of any of the provisions of this chapter by a
31 managing pharmacist or by personnel of the pharmacy under the
32 supervision of the managing pharmacist is cause for the suspension
33 or revocation of the license of the pharmacy by the Board.

34 6. The provisions of this section do not prohibit:

35 (a) A Canadian pharmacy which is licensed by the Board and
36 which has been recommended by the Board pursuant to subsection 4
37 of NRS 639.2328 for inclusion on the Internet website established
38 and maintained pursuant to paragraph (i) of subsection 1 of NRS
39 223.560 from providing prescription drugs through mail order
40 service to residents of Nevada in the manner set forth in NRS
41 639.2328 to 639.23286, inclusive; or

42 (b) A registered pharmacist or practitioner from collaborating in
43 ~~the implementation, monitoring and modification of drug therapy~~
44 ~~pursuant to guidelines and protocols approved by the Board.]~~ *a*
45 *collaborative practice agreement.*



Sec. 9.5. NRS 639.2809 is hereby amended to read as follows:

639.2809 1. Written guidelines and protocols developed by a registered pharmacist in collaboration with a practitioner which authorize ~~{the implementation, monitoring and modification of}~~ **collaborative** drug therapy ~~{}~~ **management**:

(a) May authorize a pharmacist to order and use the findings of laboratory tests and examinations.

(b) May provide for ~~{implementation, monitoring and modification of}~~ **collaborative** drug therapy **management** for a patient receiving care:

(1) In a licensed medical facility; or

(2) If developed to ensure continuity of care for a patient, in any setting that is affiliated with a medical facility where the patient is receiving care. A pharmacist who modifies a drug therapy of a patient receiving care in a setting that is affiliated with a medical facility shall, within 72 hours after ~~{implementing}~~ **initiating** or modifying the drug therapy, provide written notice of the ~~{implementation}~~ **initiation** or modification of the drug therapy to the collaborating practitioner or enter the appropriate information concerning the drug therapy in an electronic patient record system shared by the pharmacist and the collaborating practitioner.

(c) Must state the conditions under which a prescription of a practitioner relating to the drug therapy of a patient may be changed by the pharmacist without a subsequent prescription from the practitioner.

(d) Must be approved by the Board.

2. The Board may adopt regulations which:

(a) Prescribe additional requirements for written guidelines and protocols developed pursuant to this section; and

(b) Set forth the process for obtaining the approval of the Board of such written guidelines and protocols.

Sec. 10. NRS 453.026 is hereby amended to read as follows:

453.026 "Agent" means a pharmacist who cares for a patient of a prescribing practitioner in a medical facility or in a setting that is affiliated with a medical facility where the patient is receiving care in accordance with written guidelines and protocols developed and approved pursuant to NRS 639.2809 ~~{}~~ **or a collaborative practice agreement, as defined in section 2 of this act**, a licensed practical nurse or registered nurse who cares for a patient of a prescribing practitioner in a medical facility or an authorized person who acts on behalf of or at the direction of and is employed by a manufacturer, distributor, dispenser or prescribing practitioner. The term does not include a common or contract carrier, public warehouseman or employee of the carrier or warehouseman.



Sec. 11. NRS 454.213 is hereby amended to read as follows:

454.213 1. A drug or medicine referred to in NRS 454.181 to 454.371, inclusive, may be possessed and administered by:

(a) A practitioner.

(b) A physician assistant licensed pursuant to chapter 630 or 633 of NRS, at the direction of his or her supervising physician or a licensed dental hygienist acting in the office of and under the supervision of a dentist.

(c) Except as otherwise provided in paragraph (d), a registered nurse licensed to practice professional nursing or licensed practical nurse, at the direction of a prescribing physician, physician assistant licensed pursuant to chapter 630 or 633 of NRS, dentist, podiatric physician or advanced practice registered nurse, or pursuant to a chart order, for administration to a patient at another location.

(d) In accordance with applicable regulations of the Board, a registered nurse licensed to practice professional nursing or licensed practical nurse who is:

(1) Employed by a health care agency or health care facility that is authorized to provide emergency care, or to respond to the immediate needs of a patient, in the residence of the patient; and

(2) Acting under the direction of the medical director of that agency or facility who works in this State.

(e) A medication aide - certified at a designated facility under the supervision of an advanced practice registered nurse or registered nurse and in accordance with standard protocols developed by the State Board of Nursing. As used in this paragraph, "designated facility" has the meaning ascribed to it in NRS 632.0145.

(f) Except as otherwise provided in paragraph (g), an advanced emergency medical technician or a paramedic, as authorized by regulation of the State Board of Pharmacy and in accordance with any applicable regulations of:

(1) The State Board of Health in a county whose population is less than 100,000;

(2) A county board of health in a county whose population is 100,000 or more; or

(3) A district board of health created pursuant to NRS 439.362 or 439.370 in any county.

(g) An advanced emergency medical technician or a paramedic who holds an endorsement issued pursuant to NRS 450B.1975, under the direct supervision of a local health officer or a designee of the local health officer pursuant to that section.

(h) A respiratory therapist employed in a health care facility. The therapist may possess and administer respiratory products only at the direction of a physician.



(i) A dialysis technician, under the direction or supervision of a physician or registered nurse only if the drug or medicine is used for the process of renal dialysis.

(j) A medical student or student nurse in the course of his or her studies at an accredited college of medicine or approved school of professional or practical nursing, at the direction of a physician and:

(1) In the presence of a physician or a registered nurse; or

(2) Under the supervision of a physician or a registered nurse if the student is authorized by the college or school to administer the drug or medicine outside the presence of a physician or nurse.

➤ A medical student or student nurse may administer a dangerous drug in the presence or under the supervision of a registered nurse alone only if the circumstances are such that the registered nurse would be authorized to administer it personally.

(k) Any person designated by the head of a correctional institution.

(l) An ultimate user or any person designated by the ultimate user pursuant to a written agreement.

(m) A nuclear medicine technologist, at the direction of a physician and in accordance with any conditions established by regulation of the Board.

(n) A radiologic technologist, at the direction of a physician and in accordance with any conditions established by regulation of the Board.

(o) A chiropractic physician, but only if the drug or medicine is a topical drug used for cooling and stretching external tissue during therapeutic treatments.

(p) A physical therapist, but only if the drug or medicine is a topical drug which is:

(1) Used for cooling and stretching external tissue during therapeutic treatments; and

(2) Prescribed by a licensed physician for:

(I) Iontophoresis; or

(II) The transmission of drugs through the skin using ultrasound.

(q) In accordance with applicable regulations of the State Board of Health, an employee of a residential facility for groups, as defined in NRS 449.017, pursuant to a written agreement entered into by the ultimate user.

(r) A veterinary technician or a veterinary assistant at the direction of his or her supervising veterinarian.

(s) In accordance with applicable regulations of the Board, a registered pharmacist who:

(1) Is trained in and certified to carry out standards and practices for immunization programs;



(2) Is authorized to administer immunizations pursuant to written protocols from a physician; and

(3) Administers immunizations in compliance with the “Standards for Immunization Practices” recommended and approved by the Advisory Committee on Immunization Practices of the Centers for Disease Control and Prevention.

(t) A registered pharmacist pursuant to written guidelines and protocols developed and approved pursuant to NRS 639.2809 ~~H~~ *or a collaborative practice agreement, as defined in section 2 of this act.*

(u) A person who is enrolled in a training program to become a physician assistant licensed pursuant to chapter 630 or 633 of NRS, dental hygienist, advanced emergency medical technician, paramedic, respiratory therapist, dialysis technician, nuclear medicine technologist, radiologic technologist, physical therapist or veterinary technician if the person possesses and administers the drug or medicine in the same manner and under the same conditions that apply, respectively, to a physician assistant licensed pursuant to chapter 630 or 633 of NRS, dental hygienist, advanced emergency medical technician, paramedic, respiratory therapist, dialysis technician, nuclear medicine technologist, radiologic technologist, physical therapist or veterinary technician who may possess and administer the drug or medicine, and under the direct supervision of a person licensed or registered to perform the respective medical art or a supervisor of such a person.

(v) A medical assistant, in accordance with applicable regulations of the:

(1) Board of Medical Examiners, at the direction of the prescribing physician and under the supervision of a physician or physician assistant.

(2) State Board of Osteopathic Medicine, at the direction of the prescribing physician and under the supervision of a physician or physician assistant.

2. As used in this section, “accredited college of medicine” has the meaning ascribed to it in NRS 453.375.
