SUMMARY—Revises provisions governing the regulation of  
applied behavior analysis. (BDR 39-633)

AN ACT relating to applied behavior analysis; creating the Board of Applied Behavior Analysis; transferring the responsibility for the regulation of applied behavior analysis from the Board of Psychological Examiners to the Board of Applied Behavior Analysis; requiring the Aging and Disability Services Division of the Department of Health and Human Services to enforce provisions of law governing applied behavior analysis and the regulations of the Board of Applied Behavior Analysis; replacing the term “autism behavior interventionist” with the term “behavior technician”; requiring a behavior technician to obtain registration from the Division; revising the composition of the Board of Psychological Examiners; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

- 1 Existing law defines the term “autism behavior interventionist” to mean a
- 2 person who is registered as a Registered Behavior Technician or an equivalent
- 3 credential by the Behavior Analyst Certification Board, Inc., or its successor
- 4 organization, and provides behavioral therapy under the supervision of certain
- 5 professionals. (NRS 641.0204) **Sections 5.3, 48 and 77** of this bill: (1) replace that
- 6 term with the term “behavior technician”; (2) remove the requirement that such a
- 7 person be registered as a Registered Behavior Technician; and (3) instead require a
- 8 behavior technician to be registered by the Division.



Under existing law, the Board of Psychological Examiners regulates the practice of applied behavior analysis and licenses behavior analysts and assistant behavior analysts. (NRS 641.100, 641.170) **Section 13.3** of this bill creates the Board of Applied Behavior Analysis. **Section 13.7** of this bill prescribes the compensation of the Board. **Sections 14 and 17** of this bill authorize the Board to adopt regulations governing: (1) the licensing of behavior analysts and assistant behavior analysts; (2) the registration of behavior technicians; and (3) the practice of applied behavior analysis. **Sections 13, 15, 16 and 18** of this bill prescribe the duties of the Aging and Disability Services Division of the Department of Health and Human Services to keep certain records and enforce provisions of law governing applied behavior analysis and the regulations of the Board of Applied Behavior Analysis. **Section 16** of this bill authorizes the Division to prescribe fees for the licensing of behavior analysts and assistant behavior analysts and the registration of behavior technicians. **Section 19** of this bill exempts an employee or agent of the Division from liability for actions taken in good faith in the performance of the duties of the Division. **Sections 20-27** of this bill prescribe the requirements to obtain or renew a license as a behavior analyst or assistant behavior analyst or registration as a behavior technician.

**Section 29** of this bill prescribes the grounds for disciplinary action against a behavior analyst, assistant behavior analyst or behavior technician, and **section 30** of this bill requires the Board to prescribe additional grounds for such disciplinary action by regulation. **Section 31** of this bill establishes the disciplinary action that the Division may impose against a behavior analyst, assistant behavior analyst or behavior technician. **Sections 33-38 and 41-43** of this bill prescribe procedures relating to the filing of a complaint and conducting an investigation and disciplinary hearing. **Sections 39 and 40** of this bill authorize the Division to require a behavioral analyst, assistant behavior analyst or behavior technician to take an examination to demonstrate his or her competence. **Sections 44 and 45** of this bill authorize the Division or the Attorney General to maintain an action to enjoin certain unprofessional conduct or the practice of applied behavior analysis without the required license or credential. **Section 46** of this bill grants immunity from liability to any person who initiates a complaint or assists in an investigation or the discipline of a behavior analyst, assistant behavior analyst or behavior technician without malicious intent. **Section 47** of this bill authorizes a behavior analyst, assistant behavior analyst or behavior technician to apply to the Division for the removal of certain administrative sanctions against his or her license. **Sections 48-50** of this bill prohibit the practice of applied behavior analysis without the proper license, credentials or supervision and certain other acts. **Section 50** makes the fraudulent practice of applied behavior analysis or practice as a behavior analyst, assistant behavior analyst or behavior technician without the proper license or credential a gross misdemeanor.

The Board of Psychological Examiners currently consists of seven members appointed by the Governor. One of the members of the Board is a licensed behavior analyst. (NRS 641.030, 641.040) **Sections 58, 59 and 74** of this bill remove that member from the Board and reduce the size of the Board to six members. **Sections 56, 57 and 60-66** of this bill remove references to applied behavior analysis from the provisions of statute administered by the Board, and **sections 53 and 67-71** of this bill make conforming changes.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** Title 39 of NRS is hereby amended by adding thereto a new chapter to consist of the provisions set forth as sections 2 to 50, inclusive, of this act.

**Sec. 2.** *As used in this chapter, unless the context otherwise requires, the words and terms defined in sections 3 to 11, inclusive, of this act have the meanings ascribed to them in those sections.*

**Sec. 3.** *“Assistant behavior analyst” means a person who holds current certification as a Board Certified Assistant Behavior Analyst issued by the Behavior Analyst Certification Board, Inc., or any successor in interest to that organization, and is licensed as an assistant behavior analyst by the Division.*

**Sec. 4.** (Deleted by amendment.)

**Sec. 5.** *“Behavior analyst” means a person who holds current certification as a Board Certified Behavior Analyst issued by the Behavior Analyst Certification Board, Inc., or any successor in interest to that organization, and is licensed as a behavior analyst by the Division.*

**Sec. 5.3.** *“Behavior technician” means a person who is registered as such by the Division and provides behavioral therapy under the supervision of:*

- 1. A licensed psychologist;*
- 2. A licensed behavior analyst; or*
- 3. A licensed assistant behavior analyst.*

**Sec. 5.8.** *“Board” means the Board of Applied Behavior Analysis created by section 13.3 of this act.*

**Sec. 6.** *“Community” means the entire area customarily served by behavior analysts and assistant behavior analysts among whom a patient may reasonably choose, not merely the particular area inhabited by the patients of an individual behavior analyst, assistant behavior analyst, behavior technician or the particular city or place where the behavior analyst, assistant behavior analyst or behavior technician has his or her office.*

**Sec. 7.** *“Division” means the Aging and Disability Services Division of the Department of Health and Human Services.*

**Sec. 8.** *“Gross malpractice” means malpractice where the failure to exercise the requisite degree of care, diligence or skill consists of:*

- 1. Practicing applied behavior analysis with a patient while the behavior analyst, assistant behavior analyst or behavior technician is under the influence of an alcoholic beverage as defined in NRS 202.015 or any controlled substance;*



2. *Gross negligence;*
3. *Willful disregard of established methods and procedures in the practice of applied behavior analysis; or*
4. *Willful and consistent use of methods and procedures considered by behavior analysts, assistant behavior analysts or behavior technicians, as applicable, in the community to be inappropriate or unnecessary in the cases where used.*

Sec. 9. *“Malpractice” means failure on the part of a behavior analyst, assistant behavior analyst or behavior technician to exercise the degree of care, diligence and skill ordinarily exercised by behavior analysts, assistant behavior analysts or behavior technicians, as applicable, in good standing in the community.*

Sec. 10. *“Practice of applied behavior analysis” means the design, implementation and evaluation of instructional and environmental modifications based on scientific research and observations of behavior and the environment to produce socially significant improvement in human behavior, including, without limitation:*

1. *The empirical identification of functional relations between environment and behavior; and*

2. *The use of contextual factors, motivating operations, antecedent stimuli, positive reinforcement and other procedures to help a person develop new behaviors, increase or decrease existing behaviors and engage in certain behavior under specific environmental conditions.*

↪ *The term includes the provision of behavioral therapy by a behavior analyst, assistant behavior analyst or behavior technician.*

Sec. 11. *“Professional incompetence” means lack of ability to practice applied behavior analysis safely and skillfully arising from:*

1. *Lack of knowledge or training;*
2. *Impaired physical or mental ability; or*
3. *Dependence upon an alcoholic beverage as defined in NRS 202.015 or any controlled substance.*

Sec. 12. *The provisions of this chapter do not apply to:*

1. *A physician who is licensed to practice in this State;*
2. *A person who is licensed to practice dentistry in this State;*
3. *A person who is licensed as a psychologist pursuant to chapter 641 of NRS;*
4. *A person who is licensed as a marriage and family therapist or marriage and family therapist intern pursuant to chapter 641A of NRS;*



1       5. A person who is licensed as a clinical professional  
2 counselor or clinical professional counselor intern pursuant to  
3 chapter 641A of NRS;

4       6. A person who is licensed to engage in social work pursuant  
5 to chapter 641B of NRS;

6       7. A person who is licensed as an occupational therapist or  
7 occupational therapy assistant pursuant to NRS 640A.010 to  
8 640A.230, inclusive;

9       8. A person who is licensed as a clinical alcohol and drug  
10 abuse counselor, licensed or certified as an alcohol and drug  
11 abuse counselor or certified as an alcohol and drug abuse  
12 counselor intern, a clinical alcohol and drug abuse counselor  
13 intern, a problem gambling counselor or a problem gambling  
14 counselor intern, pursuant to chapter 641C of NRS; or

15       9. Any member of the clergy,  
16       ↪ if such a person does not commit an act described in section 50  
17 of this act or represent himself or herself as a behavior analyst,  
18 assistant behavior analyst or behavior technician.

19       **Sec. 13. 1. The Division shall make and keep:**

20       (a) A record of all violations and prosecutions under the  
21 provisions of this chapter.

22       (b) A register of all licenses and registrations.

23       (c) A register of all holders of licenses and registrations.

24       2. These records must be kept in an office of the Division  
25 and, except as otherwise provided in this section, are subject to  
26 public inspection during normal working hours upon reasonable  
27 notice.

28       3. Except as otherwise provided in NRS 239.0115, the  
29 Division may keep the personnel records of applicants  
30 confidential.

31       4. Except as otherwise provided in this section and NRS  
32 239.0115, a complaint filed with the Division, all documents and  
33 other information filed with the complaint and all documents and  
34 other information compiled as a result of an investigation  
35 conducted to determine whether to initiate disciplinary action  
36 against a person are confidential, unless the person submits a  
37 written statement to the Division requesting that such documents  
38 and information be made public records.

39       5. The charging documents filed with the Division to initiate  
40 disciplinary action pursuant to chapter 622A of NRS and all other  
41 documents and information considered by the Division when  
42 determining whether to impose discipline are public records.

43       6. The provisions of this section do not prohibit the Division  
44 from communicating or cooperating with or providing any  
45 documents or other information to any licensing board or any

1 *other agency that is investigating a person, including, without*  
2 *limitation, a law enforcement agency.*

3 **Sec. 13.3.** 1. *The Board of Applied Behavior Analysis is*  
4 *hereby created.*

5 2. *The Governor shall appoint to the Board:*

6 (a) *Three voting members who are behavior analysts licensed*  
7 *in this State.*

8 (b) *One voting member who is an assistant behavior analyst*  
9 *licensed in this State.*

10 (c) *One voting member who is a representative of the general*  
11 *public who is interested in the practice of applied behavior*  
12 *analysis. This member must not be a behavior analyst or assistant*  
13 *behavior analyst, an applicant or a former applicant for licensure*  
14 *as a behavior analyst or assistant behavior analyst, a member of a*  
15 *health profession, the spouse or the parent or child, by blood,*  
16 *marriage or adoption, of a behavior analyst or assistant behavior*  
17 *analyst, or a member of a household that includes a behavior*  
18 *analyst or assistant behavior analyst.*

19 3. *The Administrator of the Division or his or her designee is*  
20 *an ex officio, nonvoting member of the Board.*

21 4. *After the initial term, the Governor shall appoint each*  
22 *member of the Board to a term of 4 years. No member of the*  
23 *Board may serve more than two consecutive terms.*

24 5. *The Board shall hold a regular meeting at least once a*  
25 *year. The Board shall hold a special meeting upon a call of the*  
26 *President or upon the request of a majority of the members. A*  
27 *majority of the Board constitutes a quorum.*

28 6. *At the regular annual meeting, the Board shall elect from*  
29 *its membership a President and a Secretary-Treasurer, who shall*  
30 *hold office for 1 year and until the election and qualification of*  
31 *their successors.*

32 7. *A member of the Board or an employee or agent of the*  
33 *Board is not liable in a civil action for any act performed in good*  
34 *faith and within the scope of the duties of the Board pursuant to*  
35 *the provisions of this chapter.*

36 **Sec. 13.7.** 1. *Each member of the Board is entitled to*  
37 *receive:*

38 (a) *A salary of not more than \$150 per day, as fixed by the*  
39 *Board, while engaged in the business of the Board; and*

40 (b) *A per diem allowance and travel expenses at a rate fixed by*  
41 *the Board, while engaged in the business of the Board. The rate*  
42 *must not exceed the rate provided for state officers and employees*  
43 *generally.*

44 2. *While engaged in the business of the Board, each employee*  
45 *of the Board is entitled to receive a per diem allowance and travel*



1 *expenses at a rate fixed by the Board. The rate must not exceed the*  
2 *rate provided for state officers and employees generally.*

3 *3. Compensation and expenses of the members and*  
4 *employees of the Board are payable out of the money derived from*  
5 *fees paid or transmitted to the Board pursuant to the provisions of*  
6 *this chapter and no part thereof may be paid out of the State*  
7 *Treasury.*

8 *Sec. 14. The Board may make and promulgate rules and*  
9 *regulations not inconsistent with the provisions of this chapter*  
10 *governing its procedure, the examination and licensure or*  
11 *registration of applicants, the granting, refusal, revocation or*  
12 *suspension of licenses or registrations and the practice of applied*  
13 *behavior analysis.*

14 *Sec. 15. The Division shall enforce the provisions of this*  
15 *chapter and may, under the provisions of this chapter:*

16 *1. Examine and pass upon the qualifications of applicants for*  
17 *licensure and registration.*

18 *2. License and register qualified applicants.*

19 *3. Conduct investigations of licensees and registrants.*

20 *4. Revoke or suspend licenses and registrations.*

21 *5. Collect all fees and make disbursements pursuant to this*  
22 *chapter.*

23 *Sec. 16. 1. The Division shall prescribe, by regulation, fees*  
24 *for the issuance, renewal and reinstatement of a license or*  
25 *registration and any other services provided by the Division*  
26 *pursuant to this chapter. The Division shall ensure, to the extent*  
27 *practicable, that the amount of such fees is sufficient to pay the*  
28 *costs incurred by the Board and the Division under the provisions*  
29 *of this chapter, including, without limitation, the compensation of*  
30 *the Board prescribed by section 13.7 of this act, and does not*  
31 *exceed the amount necessary to pay those costs.*

32 *2. Money received from licensing behavior analysts and*  
33 *assistant behavior analysts and registering behavior technicians,*  
34 *civil penalties collected pursuant to this chapter and any*  
35 *appropriation, gift, grant or donation received by the Board or the*  
36 *Division for purposes relating to the duties of the Board or the*  
37 *Division under the provisions of this chapter must be deposited in*  
38 *a separate account in the State General Fund. The account must*  
39 *be administered by the Division. Money in the account must be*  
40 *expended solely for the purposes of this chapter and does not*  
41 *revert to the State General Fund. The compensation provided for*  
42 *by this chapter and all expenses incurred under this chapter must*  
43 *be paid from the money in the account.*

44 *Sec. 17. 1. A licensed behavior analyst or assistant*  
45 *behavior analyst or registered behavior technician shall limit his*



1 *or her practice of applied behavior analysis to his or her areas of*  
2 *competence, as documented by education, training and*  
3 *experience.*

4 *2. The Board shall adopt regulations to ensure that licensed*  
5 *behavior analysts, assistant behavior analysts and registered*  
6 *behavior technicians limit their practice of applied behavior*  
7 *analysis to their areas of competence.*

8 **Sec. 18.** *In a manner consistent with the provisions of*  
9 *chapter 622A of NRS, the Division may hold hearings and*  
10 *conduct investigations related to its duties under this chapter and*  
11 *take evidence on any matter under inquiry before it.*

12 **Sec. 19.** *An employee or agent of the Division is not liable in*  
13 *a civil action for any act performed in good faith and within the*  
14 *scope of the duties of the Division pursuant to the provisions of*  
15 *this chapter.*

16 **Sec. 20.** *1. Each person desiring a license as a behavior*  
17 *analyst or assistant behavior analyst or registration as a behavior*  
18 *technician must:*

19 *(a) Make application to the Division upon a form and in a*  
20 *manner prescribed by the Division. The application must be*  
21 *accompanied by the application fee prescribed by the Division and*  
22 *include all information required to complete the application.*

23 *(b) As part of the application and at his or her own expense:*

24 *(1) Arrange to have a complete set of fingerprints taken by*  
25 *a law enforcement agency or other authorized entity acceptable to*  
26 *the Division; and*

27 *(2) Submit to the Division:*

28 *(I) A complete set of fingerprints and written permission*  
29 *authorizing the Division to forward the fingerprints to the Central*  
30 *Repository for Nevada Records of Criminal History for submission*  
31 *to the Federal Bureau of Investigation for a report on the*  
32 *applicant's background, and to such other law enforcement*  
33 *agencies as the Division deems necessary for a report on the*  
34 *applicant's background; or*

35 *(II) Written verification, on a form prescribed by the*  
36 *Division, stating that the set of fingerprints of the applicant was*  
37 *taken and directly forwarded electronically or by other means to*  
38 *the Central Repository for Nevada Records of Criminal History*  
39 *and that the applicant provided written permission authorizing the*  
40 *law enforcement agency or other authorized entity taking the*  
41 *fingerprints to submit the fingerprints to the Central Repository*  
42 *for Nevada Records of Criminal History for submission to the*  
43 *Federal Bureau of Investigation for a report on the applicant's*  
44 *background, and to such other law enforcement agencies as the*

1 *Division deems necessary for a report on the applicant's*  
2 *background.*

3 *2. The Division may:*

4 *(a) Unless the applicant's fingerprints are directly forwarded*  
5 *pursuant to sub-subparagraph (II) of subparagraph (2) of*  
6 *paragraph (b) of subsection 1, submit those fingerprints to the*  
7 *Central Repository for Nevada Records of Criminal History for*  
8 *submission to the Federal Bureau of Investigation and to such*  
9 *other law enforcement agencies as the Division deems necessary;*  
10 *and*

11 *(b) Request from each agency to which the Division submits*  
12 *the fingerprints any information regarding the applicant's*  
13 *background as the Division deems necessary.*

14 *3. An application is not considered complete and received for*  
15 *purposes of evaluation pursuant to subsection 4 of section 21 of*  
16 *this act until the Division receives a complete set of fingerprints or*  
17 *verification that the fingerprints have been forwarded*  
18 *electronically or by other means to the Central Repository for*  
19 *Nevada Records of Criminal History, and written authorization*  
20 *from the applicant pursuant to this section.*

21 **Sec. 21.** *1. Except as otherwise provided in sections 23 and*  
22 *24 of this act, each application for licensure as a behavior analyst*  
23 *must be accompanied by evidence satisfactory to the Division that*  
24 *the applicant:*

25 *(a) Is of good moral character as determined by the Division.*

26 *(b) Is a citizen of the United States or is lawfully entitled to*  
27 *remain and work in the United States.*

28 *(c) Holds current certification as a Board Certified Behavior*  
29 *Analyst issued by the Behavior Analyst Certification Board, Inc.,*  
30 *or any successor in interest to that organization.*

31 *2. Each application for licensure as an assistant behavior*  
32 *analyst must be accompanied by evidence satisfactory to the*  
33 *Division that the applicant:*

34 *(a) Is of good moral character as determined by the Division.*

35 *(b) Is a citizen of the United States or is lawfully entitled to*  
36 *remain and work in the United States.*

37 *(c) Holds current certification as a Board Certified Assistant*  
38 *Behavior Analyst issued by the Behavior Analyst Certification*  
39 *Board, Inc., or any successor in interest to that organization.*

40 *3. Each application for registration as a behavior technician*  
41 *must contain the information required by regulation of the Board.*

42 *4. Except as otherwise provided in sections 23 and 24 of this*  
43 *act, within 120 days after receiving an application and the*  
44 *accompanying evidence from an applicant, the Division shall:*

1     (a) Evaluate the application and accompanying evidence and  
2     determine whether the applicant is qualified pursuant to this  
3     section for licensure or registration; and

4     (b) Issue a written statement to the applicant of its  
5     determination.

6     5. If the Division determines that the qualifications of the  
7     applicant are insufficient for licensure or registration, the written  
8     statement issued to the applicant pursuant to subsection 4 must  
9     include a detailed explanation of the reasons for that  
10    determination.

11    Sec. 22. 1. In addition to any other requirements set forth  
12    in this chapter:

13    (a) An applicant for the issuance of a license as a behavior  
14    analyst or assistant behavior analyst or registration as a behavior  
15    technician shall include the social security number of the  
16    applicant in the application submitted to the Division.

17    (b) An applicant for the issuance or renewal of a license as a  
18    behavior analyst or assistant behavior analyst or registration as a  
19    behavior technician shall submit to the Aging and Disability  
20    Services Division the statement prescribed by the Division of  
21    Welfare and Supportive Services of the Department of Health and  
22    Human Services pursuant to NRS 425.520. The statement must be  
23    completed and signed by the applicant.

24    2. The Aging and Disability Services Division shall include  
25    the statement required pursuant to subsection 1 in:

26    (a) The application or any other forms that must be submitted  
27    for the issuance or renewal of the license or registration; or

28    (b) A separate form prescribed by the Division.

29    3. A license as a behavior analyst or assistant behavior  
30    analyst or registration as a behavior technician must not be issued  
31    or renewed by the Aging and Disability Services Division if the  
32    applicant:

33    (a) Fails to submit the statement required pursuant to  
34    subsection 1; or

35    (b) Indicates on the statement submitted pursuant to  
36    subsection 1 that the applicant is subject to a court order for the  
37    support of a child and is not in compliance with the order or a  
38    plan approved by the district attorney or other public agency  
39    enforcing the order for the repayment of the amount owed  
40    pursuant to the order.

41    4. If an applicant indicates on the statement submitted  
42    pursuant to subsection 1 that the applicant is subject to a court  
43    order for the support of a child and is not in compliance with the  
44    order or a plan approved by the district attorney or other public  
45    agency enforcing the order for the repayment of the amount owed



1 pursuant to the order, the Aging and Disability Services Division  
2 shall advise the applicant to contact the district attorney or other  
3 public agency enforcing the order to determine the actions that the  
4 applicant may take to satisfy the arrearage.

5 **Sec. 23. 1. The Division may issue a license by**  
6 **endorsement as a behavior analyst to an applicant who meets the**  
7 **requirements set forth in this section. An applicant may submit to**  
8 **the Division an application for such a license if the applicant**  
9 **holds a corresponding valid and unrestricted license as a behavior**  
10 **analyst in the District of Columbia or any state or territory of the**  
11 **United States.**

12 **2. An applicant for a license by endorsement pursuant to this**  
13 **section must submit to the Division with his or her application:**

14 **(a) Proof satisfactory to the Division that the applicant:**

15 **(1) Satisfies the requirements of subsection 1;**

16 **(2) Is a citizen of the United States or otherwise has the**  
17 **legal right to work in the United States;**

18 **(3) Has not been disciplined or investigated by the**  
19 **corresponding regulatory authority of the District of Columbia or**  
20 **any state or territory in which the applicant currently holds or has**  
21 **held a license as a behavior analyst; and**

22 **(4) Has not been held civilly or criminally liable for**  
23 **malpractice in the District of Columbia or any state or territory of**  
24 **the United States;**

25 **(b) A complete set of fingerprints and written permission**  
26 **authorizing the Division to forward the fingerprints in the manner**  
27 **provided in section 20 of this act;**

28 **(c) An affidavit stating that the information contained in the**  
29 **application and any accompanying material is true and correct;**

30 **(d) The fee prescribed by the Division pursuant to the**  
31 **regulations adopted pursuant to section 16 of this act; and**

32 **(e) Any other information required by the Division.**

33 **3. Not later than 15 business days after receiving an**  
34 **application for a license by endorsement as a behavior analyst**  
35 **pursuant to this section, the Division shall provide written notice**  
36 **to the applicant of any additional information required by the**

**Sec. 74.** 1. The term of the member of the Board of Psychological Examiners appointed to the Board pursuant to paragraph (b) of subsection 1 of NRS 641.040 who is incumbent on December 31, 2018, expires on that date.

2. As soon as practicable on or after January 1, 2019, the Governor shall appoint to the Board of Applied Behavior Analysis created by section 13.3 of this act:

(a) One member described in paragraph (a) of subsection 2 of section 13.3 of this act and the member described in paragraph (b) of that subsection to terms that expire on January 1, 2021; and

(b) Two members described in paragraph (a) of subsection 2 of section 13.3 of this act and the member described in paragraph (c) of that subsection to terms that expire on January 1, 2023.

**Sec. 75.** 1. Notwithstanding the amendatory provisions of sections 14, 17, 21, 24, 25, 29, 30, 60, 62 and 64 of this act transferring authority to adopt regulations from the Board of Psychological Examiners to the Board of Applied Behavior Analysis created by section 13.3 of this act, any regulations adopted by the Board of Psychological Examiners that do not conflict with the provisions of this act remain in effect and may be enforced by the Aging and Disability Services Division of the Department of Health and Human Services until the Board of Applied Behavior Analysis adopts regulations to repeal or replace those regulations.

2. Any regulations adopted by the Board of Psychological Examiners that conflict with the provisions of this act are void. The Legislative Counsel shall remove those regulations from the Nevada Administrative Code as soon as practicable after January 1, 2019.

**Sec. 76.** The Legislative Counsel shall:

1. In preparing the Nevada Revised Statutes, use the authority set forth in subsection 10 of NRS 220.120 to substitute





1 appropriately the name of any agency, officer or instrumentality of  
2 the State whose name is changed by this act for the name which the  
3 agency, officer or instrumentality previously used; and

4 2. In preparing supplements to the Nevada Administrative  
5 Code, substitute appropriately the name of any agency, officer or

11 **Sec. 78.** 1. This section and section 74 of this act become  
12 effective upon passage and approval.

13 2. Sections 1 to 71, inclusive, 73, 75, 76 and 77 of this act  
14 become effective on January 1, 2019.

15 3. Section 72 of this act becomes effective on July 1, 2026.

16 4. Sections 22 and 32 of this act expire by limitation on the  
17 date on which the provisions of 42 U.S.C. § 666 requiring each state  
18 to establish procedures under which the state has authority to  
19 withhold or suspend, or to restrict the use of professional,  
20 occupational and recreational licenses of persons who:

21 (a) Have failed to comply with a subpoena or warrant relating to  
22 a proceeding to determine the paternity of a child or to establish or  
23 enforce an obligation for the support of a child; or

24 (b) Are in arrears in the payment for the support of one or more  
25 children,
