If enacted, the proposed legislation would have a fiscal impact on the Nevada System of Higher Education (NSHE) and its institutions by requiring all NSHE institutions to pay prevailing wage rates on all projects over \$25,000.

Currently, NSHE institutions are required to pay on certain projects at 90% of the prevailing wage rates. Section 3 proposed to eliminate this exception. Additionally, Section 3 proposes to revise the methodology used by the Labor Commissioner to calculate prevailing wage rates by trade. Section 4 proposes to decrease the minimum threshold for prevailing wage requirements from \$250,000 to \$25,000. Section 36 repeals sections of NRS, which limit the provisions of NRS 338.013 to 338.018, inclusive, and NRS 338.020 to 338.090, inclusive, to NSHE contracts for construction work greater than \$250,000. Each of the proposed revisions to NRS would result in higher constructions costs for NSHE projects.
