Comment: A presidential preference primary election could result in significant fiscal impacts to Churchill County. However, it appears that section 29 of BDR 24-875 indicates that the State would cover the cost of the election, therefore reimbursing any costs incurred by the County. If this is the intent, there would be a significant burden to the State, and often times this results in the State being forced to mandate the counties to pay for other services.
