The NTA has reviewed BDR 58-1051. The requirement that all TNC drivers (the cumulative number of which is currently over 63,000) present evidence of their compliance with all business license requirements to the NTA in order to obtain a decal from the NTA will have a fiscal impact (Section 2 (4)). The NTA believes the NTA will require two (2) additional Compliance Auditors and two (2) additional Administrative Assistant II's. The NTA will also need to promote the Compliance Auditor III to a Supervisor position. The NTA would need to lease additional space in the B&I Business Center to accommodate the four (4) additional positions.

Section 3 (2) which requires the NTA to inspect the systems and software for a TNC's digital network or software application service will require filling the vacant IT position. Costs associated with filling the IT Professional II position would be absorbed by the agency pending the successful recruitment of the existing IT Professional 2 position (PCN 00049).

Pursuant to NRS 706A.140 and NAC 706A.190, the NTA sets the TNC assessment rates at the level necessary to provide for anticipated expenditures. This rate would need to be adjusted upward to provide sufficient revenue to provide for the additional expenditures required by the enactment of this legislation.
