Comment: This Bill would require insurance companies (when a patient has stage 4 cancer) to allow the use of a drug for cancer treatment without requiring that the patient first show that an alternative drug failed to work. It is difficult to determine the fiscal impact, however, with the high cost of the chemotherapy prescriptions we estimate the impact on insurance premiums might be as high as 2%, or \$34,000 per year.

Comment: This Bill would have an impact as currently we utilize a prior authorization or step therapy process for several cancer drugs. During these processes, the Pharmacy Benefit Administrator (WellDyneRx) has a pharmacy and clinical team that communicates with the physician to determine the appropriate treatment for the patient. This Bill would remove that process, which has the potential to be very costly. Removing the prior authorization or step therapy process for prescription drugs for any medical condition can be costly. In a situation where a member has metastatic, advanced, or stage 4 cancer, it can be assumed that the member will be undergoing treatment to the extent their maximum out-of-pocket has been reached and the plan is then responsible for 100% of all medical and pharmacy costs. Removing the ability for the plan to control these pharmacy costs may have a significant fiscal impact.
