Comment: This Bill requires insurance companies to cover medical treatment for chronic conditions without requiring prior authorization (if the employee had already received prior authorization before the condition was chronic). Additionally, a new insurance company is required to cover the treatment for a chronic condition if the patient's previous insurance covered it.

Any time a new required coverage is placed on an insurer, it restricts that insurer's ability to control costs. I would estimate this might raise insurance premiums 1/2 to 1 %, which would equate to \$8,500 to \$17,000 per year for Churchill County

Comment: ? According to this bill, if an insurer approves coverage for a procedure, device, medication or any other treatment for a condition for an insured, and a provider of health care determines the condition of the insured is chronic, the insurer will be prohibited from denying continued coverage for the treatment or requiring prior authorization for continued coverage. The insurer must deem the treatment approved if the policy of health insurance covers the treatment or if the insured provides evidence that his or her immediately preceding former insurer approved the treatment. Continued coverage may be denied if the insurer obtains credible evidence that the chronic condition does not exist, no longer exists or is in remission.

There is no fiscal impact to Clark County.

Although it would be difficult to quantify an exact number at this time, this bill as written will have a significant fiscal impact on the City of Reno. The requirement for one health plan to accept and cover an authorization from the employee's prior plan is problematic. "Chronic condition" covers a very broad category and clinical decisions are not always black and white. This bill would force coverage on treatments when a lower level or less invasive treatment could be a better clinical decision. Chronic conditions and the side effects are a huge portion of health care claims. Eliminating step therapies, clinical decisions and case management approval by individual case could increase claims costs for the City's Self-Insurance Group Health Insurance Plan significantly.
