Comment: BDR 23-33 falls under the "Ban the Box" movement. It does not allow a public employer to ask about an employee's criminal history until a conditional offer of employment is made. Churchill County's current job applications ask applicants about any prior convictions, and would need to be revised if this bill were to pass. Once a job offer is made, an employer can only rescind the offer based on the applicant's criminal background, only if it meets the requirements spelled out in this bill. Section 4 of this bill also seeks to exempt marijuana drug testing for state employees, which Churchill County would not want to see carried over to local government. This BDR does not appear to create a significant fiscal impact to Churchill County.

Hiring departments may decline to hire or rescind conditional offers of employment based on these criteria.
