Estimated annual cost of \$1,447.40 if three such requests were processed in a year (based on the low number of license applications for these types of businesses, and that not every applicant will request such a review prior to applying for the license.

The Sheriff's office would have an impact as well due to the time needed to meet the background check requirements. The cost to run a background check is approximately \$3,500 per person. However they can also take between 20 and 40 hours of staff time, therefore depending on the volume of applications received they may also need to hire 2 additional staff members in order to meet the additional demand. The pay range for investigative assistants is \$45,000 and \$58,400.
