Section 2 of this bill clarifies that voting records printed on paper after being recorded on a mechanical device are not subject to inspection by anyone except on a contested election. Section 3 of this bill eliminates the initial recount from just testing 5% or 3 precincts and provides that a recount must be completed on all the ballots in an election.

The County is currently recounting 100% of the ballots if a recount is requested. Recounts are paid for by the requesting party upfront.
