The bill as written calls for an insurer that issues a policy of health insurance, which provides prescription drug coverage, to ensure that at least twenty-five percent (25%) of such polices apply a co-payment structure before payment of a deductible. Doing this would likely increase the health care costs the City incurs. A deductible is implemented to provide some cost sharing between the insured and the plan sponsor, and it encourages insureds to consider the necessity of the prescription. Stacking co-payments before deductibles minimizes the effect of the deductible.

Comment: This bill would require 25 percent of policies offered by an insurer to apply a copayment structure before payment of a deductible to the entire prescription drug benefit. Additionally, insurers would not be allowed to place all the prescription drugs within a given class in the highest cost tier provided by the plan. This bill would go into effect January 1, 2018.

The fiscal impact of this bill cannot be determined; however, it is expected to negatively affect the Clark County Self-Funded Plan. Currently, the Self-Funded Plan only has one coverage option. In order to be compliant with this bill, new coverage options would have to be implemented, which would be costly. Members would be negatively impacted, as Clark County would have to increase premiums for the Self-Funded Plan in order to recoup some of the additional costs. Additionally, a January 1, 2018 effective date would not be feasible as changes would have to be made and approved before open enrollment begins in October.
