Comment: This bill establishes rules, requirements, and repercussions for medical professionals who prescribe or administer opiate painkillers. UMC would primarily be affected negatively by this bill. It requires staff to report on any suspected drug overdose cases they handle. It also requires them to specify the types of drugs that caused the overdose. This information needs to be reported daily, and summarized weekly. This will slow down staffing and possibly require additional staff. In addition, this bill requires those authorized to administer opiates to attend additional training hours, as well as continuing education credits. This could represent additional costs to UMC if they pay for this training or reimburse medical staff. It is impossible to quantify the exact fiscal impact as the number of suspected future drug overdose cases is unknown. This bill would impose extra time requirements for health practitioners to report these cases. Depending on the number of cases, this could result in more staffing required to fulfill these reporting requirements. UMC may also have a fiscal impact if it pays for nurse continuing education credits.
