Comment: At this time, the fiscal impact of BDR 23-1043 on the Nevada Department of Corrections (NDOC) cannot be determined with the information provided. The proposed amendments to statute change the timelines and procedural requirements for investigations. Amendment to NRS 284.387(2) changes verbiage from "internal administrative investigation" to just "investigation". This particular change widens the scope of this statute to include any investigation by the appointing authority.

With the changes proposed, and their application to NDOC, the department anticipates some additional need for FTE to support and comply with such a change. However the NDOC has no actual evidence or historical experience that could be used to quantify the resource needs with any degree of accuracy. The NDOC Human Resources Division may need an additional 5-7 FTE, including an additional EEO Officer, Personnel Officer, and 3-4 Administrative Assistant positions to provide the additional support that would be required. The Office of the Inspector General may need an additional 12 FTE, including 9 Criminal Investigator's, a Program Officer, and 2 Administrative Assistants. While the exact FTE numbers cannot be determined to support the proposed change to existing statute, the NDOC can identify a range of approximately 17-20 additional FTE to support this law if enacted as currently written.

Section 2 states an investigation must commence within 20 days after the date which the appointing authority becomes aware of the allegations and review documentation relating to the proposed disciplinary action and interview the employee and each potential witness to determine whether justifiable evidence exists. The proposed language requires the agency provide the employee a copy of all extensions, evidence or other actions taken by the Department of Motor Vehicles (DMV) during the investigation.

The DMV does not anticipate any changes as the process, as proposed in this Bill, is already performed today. However, due to the extensive work involved in the investigation process, it would be difficult to complete the required fact finding investigation within the 20 days proposed by this bill. There is no known fiscal impact to the Department of Motor Vehicles. The proposed implementation date of 07/01/2017 can be met.
