City/County: Clark County Approved by: David Dobrzynski, Asst Director of Finance Comment: This bill authorizes a person convicted of a felony to file a postconviction petition and requires a court to order a genetic marker analysis upon filing of such petition. The petitioner will be required to pay the cost of the genetic marker analysis. If for any reason the convicted felon/petitioner is not responsible for paying the cost of the analysis performed, the Department of Corrections upon the approval of State Prison Commissioners will absorbed the cost. This bill has no impact on Clark County operations.
