Fiscal Year 2016-17 The City of Las Vegas would experience a negative impact due to the inability of not being able to charge any licensing fees.

Fiscal Year 2017-18 Without the ability to charge any licensing fees there would continue to be a negative impact; Halfway through this fiscal year we would be able to add more dispensaries, estimated to be an additional 12. Therefore the negative impact would increase by a factor of 1.5.

Fiscal Year 2018-19 In this fiscal year, all dispensaries would be opened and operating. So the negative impact would increase.

Future Biennia--After FY20 all of the dispensaries in the City would be opened and the negative fiscal impact would remain somewhat consistent. This number does not project future growth in the City of Las Vegas and the negative fiscal impact.
