BDR 43-606 proposes to make the issuance of any first time Driving Under the Influence (DUI) citation grounds for revocation of driving privilege for not less than 185 days. A person must have an Ignition Interlock Device (IID) installed, at their own expense, in any motor vehicle operated as a condition of obtaining a restricted license.

This bill could result in a possible increase in the use of ignition interlock devices. As such, the Department of Motor Vehicles (DMV) must expect and plan for the increase. Notifications must be provided to affected individuals resulting in increased mailing costs to the Department of Motor Vehicles (DMV). The Illegal Per Se form will require revisions, law enforcement agencies must mutually agree and approve any revisions to this form.

The proposed implementation date of 10/01/2018 can be met based on the amended language in this Bill.

To calculate all potential mailing costs associated with the projected increase in ignition interlock users, mailing costs had to be determined per person. To calculate the mailing cost, the cost per Illegal Per Se Response Letter was summed based on the integral parts of the mailing process.
