SUMMARY- Revises provisions related to energy efficiency programs. (BDR 58-568)

The proposed statute will require the Public Utilities Commission ("Commission") to engage in the following activities:

As originally written, SB 150 had no fiscal impact to the PUCN, however, the proposed amendments do have an impact to the agency. Section 8 requires the PUCN to regularly establish goals for Energy Efficiency and monitor their compliance. We estimate the proposed amendments would require (1) additional full-time Sr Attorney, (1) part-time Sr Attorney, and (1) part-time Regulatory Economist which totals \$487,618 for the biennium.

This bill may also cause a fiscal impact to the PUCN when viewed cumulatively with the other pending energy bills of this session.

The PUCN budget is funded primarily through an annual regulatory assessment (mill rate) levied against public utilities in the state for which receive recovery from their ratepayers. Pursuant to NRS 704.033, the PUCN is required to notify utilities of the annual assessment by June 15th of each year for the following fiscal year. The statutory maximum assessment is 3.5 mills. The fiscal impact would raise the annual regulatory assessment by .12 mills (0.00012) which will have an impact on the monthly residential ratepayer of one cent (\$.01).
