Sec. 6. 5. (d) limits the money in the Endowment Account (BA 1094) that may be expended for "the costs of marketing" (BA 1092 Cat 20) to 3% of the Endowment Account revenue.

Sec. 6. 5. (e) limits the money in the Endowment Account (BA 1094) that may be expended for "the costs of providing programs for financial education" (BA 1092 Cat 21) to 3% of the Endowment Account revenue.

As requested by the Nevada College Savings Board and as previously submitted and approved by the two money committees, in FY18 and FY19 the cost of marketing (Cat 20) is approved at \$800,000 per year and the cost of providing programs for financial education (Cat 21) is approved at \$175,000 per year. The three percent (3%) Endowment Account fund map contribution for these two expenditure accounts, as per this amendment, is limited to \$121,917 in FY18 and \$120,431 in FY19. Therefore in FY18 BA 1092 would require a General Fund appropriation of \$731,166 and in FY19 a General Fund appropriation of \$734,138 to fully fund the expenditure categories previously approved by the two money committees.
