City/County: <b>City of Henderson</b> Approved by: Mike Cathcart, Business Operations Manager Comment: The proposed legislation could have a fiscal impact to the City of Henderson. However, no fee schedules for the required applicator license and government agency license are included in the bill. If the City were to decide to exclusively provide pest control services with City staff then up to 50 applicator licenses and one government agency license would be necessary. Currently, the City contracts with a private sector pest control company for many of our public facilities.

City/County: <b>City of Elko</b> Approved by: Curtis Calder, City Manager Comment: The City of Elko believes BDR 49-176 will create a fiscal impact, predominately within our Parks & Recreation Department. We believe initial certification will cost \$200 per employee (fee, time & travel), and approximately \$300 per employee every 3rd year for continuing education. First year cost = \$4,000 (including point of contact time/labor). Third year cost = \$5,000

Adding this requirement will cost the county in the amount of the fee, as well as staff time applying for the fee.

City/County: <b>Washoe County</b> Approved by: Lisa Gianoli, Lobbyist Comment: The BDR provides for fees in various areas included a testing fee (Sec 12.3) and a license fee (Sec 13.1). The fees have not been established, but will have a fiscal impact on Washoe County, specifically Park Maintenance and Road Maintenance (weed control along public roads/ditches). Under the current language, Washoe County would be required to obtain a Government Agency License. Additionally, many employees of Washoe County (specifically in Road Maintenance and Park Maintenance) would be required to test and obtain a Government Applicator certification. The number of employees needing the certification probably ranges from 10-20 employees.
