Comment: This bill revises provisions related to training in JJ facilities to incorporate LGBTQ training and treating the child as having the gender they identify with. Sections 3, 4, 23, 28, 29, 37, 41 and 46 of this bill require each JDC to treat a child for whom the institution or agency is responsible as having the gender with which the child identifies, regardless of the biological sex of the child. Sections 4, 6, 10, 24, 29, 31, 38, 43 and 47 of this bill require each employee of such an institution or agency who comes into direct contact with children to receive, within 30 days after being hired, at least 2 hours of training on working with LGBTQ children. This bill will increase the requirement of tracking specialized training but will not have a fiscal impact as LGBTQ training is currently included in Juvenile Services mandatory Prison Rape Elimination Act (PREA) training.
